Course Description: When building equipment under BAS control is not working properly, how do you determine if it truly is a BAS controls problem, a mechanical malfunction or some type of electrical issue?

Understanding how to properly use a digital multimeter and knowing how to check a BAS Field Controller for correct power, communications and I/O operations is essential to successfully resolving the problem.

Following this course, participants will be able to:

- Properly and safely use a digital multimeter as a diagnostic tool.
- Distinguish various reference signals supported by Alerton BAS controllers.
- Understand what power supply and grounding requirements are necessary for Alerton BAS controllers to fully function.
- Test & Analyze all Input and Output signals common to Alerton BAS controllers, including 24VAC BO's, 0-10VDC AO's, 4-20mA Al's & AO's, Resistance Al's and Continuity Bl's.
- Identify key components of proper BACnet MS/TP communication wiring installations.
- Replace a failed Alerton BAS controller.

Target Audience: Facilities Operators and Site Technicians who are responsible for the day to day operations of buildings equipped with any version of the Alerton BACnet BAS operating software and hardware will greatly benefit from this course.

Prerequisite: Class participants must have a working knowledge and familiarity with Alerton BACnet software. Should any potential class participant not meet this requirement, Syserco offers a separate Alerton Compass Operator's training class (CUST-1002) which will equip students to fully benefit from the content of our CUST-1003 Field Level Troubleshooting course.
