July

- □ Confirm date and time of first mandated bus evacuation drill with assigned bus company
- □ Certify the completion and submission of documentation for all required bus evacuation drills for the program year

September

For our purposes, any staff that may participate on field trips or special HS sponsored bus trips are considered "bus monitors". Please note that transportation safety and bus evacuation staff training must occur prior to the first bus outing. The recommendation is that agencies make this training a part of their annual pre-service training and repeat as needed.

GOALS:

- 100% compliance with 30-Day Transportation Requirements; Staff training and Pedestrian Safety/Education
- 100% completion of 2nd and 3rd bus evacuation drills prior to the end of the program year.
- Development and implementation of Delegate Agency Transportation evaluation survey.
