# **The Leadership School September 2021 Financial Report**

Cash Position - 8/30/21: \$166,839

Cash Position - 9/30/21: \$158,518

Summary: Restricted grant of 10K received in September. Monthly spend trending at just over 20K, slightly below prior months. Q1 spending 10K less than budget, clear evidence of leadership focus on expense management. With 100K of obligated costs, current cash balance allows school to operate as planned through end of q2. Given better than expected enrollment numbers at this time, school is hitting milestones needed to keep moving forward, and will learn in November if second installment of operating grant will be received as planned.
