Dear Neighbors,

I am honored to be submitting my first annual report to you as BMAC's new Chief Executive Officer. I'm very proud to lead this extraordinary team and to be working with all of you to champion our critical mission of ending poverty in our region.

The results we share in this year's report demonstrate exceptional efforts and hard work by our team to reach clients throughout Walla Walla, Columbia, and Garfield Counties. They also show that our neighbors continue to struggle to meet their basic needs of food and housing and to have the tools they need to thrive.

While regional poverty rates in Walla Walla and Columbia Counties dropped to 7.2% in 2021, they rose back up to 12.8% in 2022. Garfield County as of 2021 had 9.23% of residents in poverty. COVID-era investments made a big difference in people's lives, so losing those programs while costs of food, gas, and housing are rising has created significant burdens on our clients. We will continue to work diligently to help remove barriers to people accessing our services so we can decrease future poverty rates and transform lives across our region.

We could not do this work without your help. We are grateful to live in a generous community where so many donate their time, treasure, and talent to changing lives for the better. Thank you for being part of our team and for all you do to help our neighbors in need. Together, we are building thriving communities.

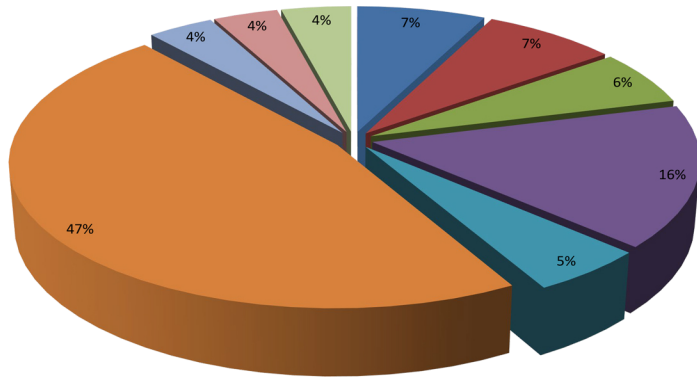
