#### Purpose

 To present the summary results of the 2023 Voluntary Stewardship Program (VSP) stakeholder survey

## The Voluntary Stewardship Program (VSP)

- Protects critical areas (wetlands, frequently flooded areas, aquifer recharge areas, geologically hazardous areas & fish and wildlife habitats) while maintaining agricultural viability
- An alternative to the Growth Management Act
- 27 counties have opted-in to VSP
- Each county:
  - Created a county work group to provide strategic direction
  - Has an approved county-wide work plan with goals & benchmarks
- Most counties use their local CD for the on-the-ground implementation
- County-wide plans were approved and are being implemented with 2-year and 5-year reporting requirements



#### VSP Outreach & Communications

- Meetings, including annual, quarterly and monthly
- Newsletter:
  - Nearly 1,000 subscribers
  - 84 issues over seven years
  - Variety of topics
    - Meeting notices
    - Policy and procedure notices & discussions
    - Success stories
- Webpage:
  - Required by statute for the Statewide Advisory
     Committee
  - Moved to its own website in 2023
- Surveys:
  - 2022 by SCC Communications staff
  - 2023 by both SCC Communications and VSP staff



### 2022 Survey

- Conducted by SCC Communications staff in Summer 2022
- Purpose: directed at VSP communications and web page development
- 13 respondents
- 15 total questions:
  - 12 check-the-box questions
  - 3 short answer / open ended questions



## October 2023 VSP Survey

- VSP and SCC Communications staff worked together on the survey in late summer 2023
- Notice in the September 2023 newsletter
- Open to any VSP stakeholder
- October 2023 survey
  - 54 respondents
  - 24 total questions:
    - 10 check-the-box questions
    - 14 short answer open ended questions

### October 2023 VSP Survey







#### How Satisfied.....




The majority were *very* satisfied and somewhat satisfied responses are in **blue**.

**Green** was *not satisfied*.


Monitoring symposiums and trainings and SCC communications about VSP skewed toward *not* satisfied.


#### What Information Would You Like More Of......

## What Barriers Are There To Training...



- Not enough time to attend (32%)
- VSP allocation for training (\$4,000) is not enough to support travel to attend (20%)
- Need more in-person trainings (15%),
- Training not relevant to my needs (14%)
- Capacity: Not enough staff to cover duties while I am training (9.9%)
- *Other* (9.9%)

### Summary of Main Themes

- Communications:
  - Including the newsletter, trainings, and website. Themes include making communications easier, simpler, and addressing a wider variety of VSP-related topics.
- SCC staff and CD staff capacity:
  - To attend county work group meetings, to put on and attend more trainings, including monitoring symposiums and field trainings, and to put on and attend more regional and statewide meetings
- SCC policy choices:
  - To review programmatic choices made in prior years, including locally-led versus state-led emphasis on control and direction of county work plans, reporting, outreach, education and monitoring; and new policy choices that could be made, including eliminating the two-year report or moving its due date, the monitoring plan requirement, and capital funding guidelines.
- February 6, 2024, VSP Stakeholder Feedback meeting Spokane CD 9am-12 noon present these results, receive feedback, and brainstorm ideas for the program.
