



2023 MEA Election Results

This year's membership election saw an 11.5% voter turnout, slightly up from the previous year. Among members who voted, 42% voted online using their SmartHub account while 57% voted by mail-in ballot, and 1% of voters voted in-

person at the Annual Meeting. There were two At-Large Board of Directors seats up for election. The candidate with the most votes was Dan Tucker (incumbent), and the candidate with the second most votes was Anastasia Buretta. Director Tucker will serve a four-year term and Director Buretta will serve a three-year term per MEA's board resolution regarding staggering board seats. All four proposed bylaw changes were passed by voters as well. The election results were certified at the May board meeting and can be reviewed on the website www.mea.coop

Next year's election will include the Susitna East and Susitna West Board of Director's seats. Candidate applications will be open in mid-December of this year.

Director Peter Burchell Honored for his MEA Board Service



2Q Rates: No Change in base rates, slight decrease in COPA rate

In the second quarter of 2023, MEA members saw no change to base rates (also known as the "energy charge") as approved by the MEA Board of Directors. Also in the 2Q, the COPA (cost of power adjustment) component of rates, which primarily recovers fuel and purchased power costs, decreased slightly by approximately 0.2%, and was reviewed and approved by the Regulatory Commission of Alaska (RCA). This is the second decrease in the COPA rate this year. Members can review the current rates sheet on the website at www.mea.coop or request a copy at any MEA office. MEA's rates are evaluated quarterly, and rate changes must be submitted by our Board of Directors and approved by the RCA.

Summer Power Line Easement Clearing



MEA is committed to providing safe, reliable power to our members. Effective vegetation management is vital in the effort to reduce tree-related outages. This year MEA clearing and contract crews will be focusing easement clearing efforts in the communities of:

- Palmer to Trunk Rd. (North Palmer/Bailey Hill neighborhoods, Equestrian Acres, neighborhoods on south side of Palmer-Wasilla Hwy from tsunami center to Trunk, Trunk from Palmer-Wasilla Hwy. to Palmer Fishhook, E. Industrial Way, Arctic Ave/Old Glenn out to Smith Road)
- Butte (Smith Road, Old Glenn from Palmer to Knik River Road, Maud Road)
- Lazy Mountain
- Tanaina (Schrock Roads to Seldon)
- Wasilla-Fishhook and Palmer-Fishhook
- Big Lake (W. Big Lake Road and roads off of W. Big Lake Road, Northshore, W. Lakes Blvd. Horseshoe Lake, Little & Big Beaver Lakes, Rocky Lake)

Easement clearing will take place from May through October. Typical power line easements for distribution lines are 30 feet wide (or 15 feet from the center of the pole on each side). A 2023 easement clearing map is available to review online at: www.mea.coop/mapping/clearingcurrent

When crews are ready to start clearing the rights-of-way, members in the area will receive an auto-call at least four days prior to any clearing activity near their property. The easements will be marked with flagging tape in advance of any clearing as well. MEA's goal is to cause the least amount of disruption in your area and we appreciate you keeping easements safe for our workers and clear of debris, vehicles, fences, and animals.
