## Borrowers Beware

Have you ever borrowed a friend, family member or co-worker's car without first checking that it is registered? Most of us would assume, when borrowing a car that it is registered. But borrowers should beware, if you are caught driving an unregistered vehicle, you may be slapped with a fine, whether or not you are the vehicle owner.

As of 1 January 2014 registration labels have not been issued and are no longer required to be displayed on all light vehicles registered in Victoria, including cars. The small change is set to save Victorians millions of dollars but some are concerned that the change might lead to an increase in unregistered vehicle related offences and fines.

Section 7 of the Road Safety Act 1986 (Vic) makes it an offence to use an unregistered vehicle on a highway, failing a permit to do so. Any driver, whether or not they are the owner of the vehicle, may be fined if caught driving an unregistered vehicle. Persons borrowing their friend or family member's car can no longer just check the sticker on the front windscreen but should ensure that they enquire about the registration status of the car

before taking it out on the roads. Employees driving company cars should do the same because although the company might end up covering the fine, any demerit points will fall on the driver.

Driver's borrowing someone else's car should take the time to ensure that the vehicle is registered. Anyone can check the registration status of a vehicle by entering the plate details online at vre.vicroads.vic.gov.au or by calling VicRoads on 13 11 71.

## Commemorated by Law

#### Anzac Day Act 1958 (Vic)

Commemorating the first major military action taken by Australian and New Zealand Army Corp (ANZAC) soldiers, the 25th of April first became known as "ANZAC Day" in 1916, just one year on from the landing at Gallipoli beach in 1915. Almost 100 years later and ANZAC Day is still recognised with various memorial services and parades across the nation. The preservation of 25 April as a day of commemoration and remembrance must be attributed, at least in part, to the fact that it has long been recognised and established by statute.

Under the current Victorian legislation, sporting events cannot be held on ANZAC Day without Ministerial approval, and even then, not before 1pm. This includes bicycle races, foot races, cricket matches, football matches or "any other game, exercise or contest of a kind usually conducted, carried on, contested or decided on a ground ... or in any building to which persons are admitted on payment of an admission fee or charge or after any donation has been sought from them for the purpose of witnessing the same." Interestingly, this does not include horse or dog races.

Similarly, cinemas across the State won't be screening movies before 1pm, unless they have been granted Ministerial approval to do

so. In fact, entertainment of any other form running before 1pm on April 25th requires a permit and must not detract from the ANZAC Day ceremonies. Also, factories and warehouses will remain closed for the entire day.

But even though many businesses and organizations won't be up and running until the afternoon, there is still plenty to do this ANZAC Day, with dawn and morning services in towns all across the country to honor those who gave their lives.
