When Do You Have To Pay Commission?

It's a familiar scene: you get your property ready for sale, you find a real estate agent and then they sell the house for you. Once settlement has gone through and all the paperwork is done, you only then have to pay the agent their commission – right?



Well, no, not necessarily. Did you know that the agreement you have with your agent entitles them to their commission even when:

- You don't proceed with the sale
- You get an offer that matches, or is above your 'Vendor's Price' – even if you don't accept the offer
- A purchaser's deposit cheque is dishonoured
- You proceed to settlement but the purchaser pulls out at the last moment

How can you prevent this from happening? Please seek our advice *before* you sign an 'Exclusive Authority Agreement' with your agent.

Loan or Gift

Tracy and Sam are a young newlywed couple on the search for their first home. After spending countless hours looking for the perfect home in their ideal price range, they realize that, like many young people, they are short of cash. So Tracy and Sam decide to call upon Tracy's parents for assistance. Tracy's mum and dad agree to provide some money to help Tracy and Sam buy the perfect home, and things are great. However, if after a while Tracy and Sam separate, will the money received from Tracy's parents be considered a loan or a gift?

As common as this scenario is, it is a complicated area and there is no clear legislation as to whether an advancement from a parent should be considered a loan or a gift. Fortunately there have been two recent Court cases in which the Court has had to determine a situation similar to the one above.

Australia's Anti-Spam Legislation

Spam is the term used to refer to electronic 'junk mail', unsolicited emails or messages received by a person through email or on their mobile phone. The content of spam messages varies from promotion of an organisation's products or services to offensive material, viruses or fraudulent activity.

In Australia, legislation has been implemented to deal with unsolicited electronic communications. The *Spam Act 2003*, covers email, instant messaging, SMS (text messages) and MMS (imagebased mobile phone messaging) messages of a commercial nature.

If your business or organisation sends any of these kinds of communications, then you have a responsibility to ensure you follow the rules.
