- 1. The February 9, 2022 meeting of the Aberdeen Catholic School System Board was called to order by President, Kristie Martin.

These costs are associated with updating the system firewall.

The Science teachers discovered many obstacles when requiring students to take part. Next year students are encouraged to take part but only by choice. Tammy Kost shared that our Kindergarten enrollment is at 30 with 3 more students expected to register very soon. This is in line with our numbers at the same time last year.
