DEPARTMENT: PUBLIC HEALTH Mineral County LOCATION:

Position is non-exempt and will at times require absence from the office, attendance at night and/or weekend meetings or events. Employee can perform some duties from home and is free to organize their work schedule in such a fashion as to accommodate their workload.

GENERAL STATEMENT OF DUTIES:

Under the direction of the Public Health Director, this person will be primarily responsible for assisting nursing staff in COVID-19 testing, COVID-19 vaccination clinics, as well as data entry for COVID-19 testing and vaccinating. Assist with contact tracing and case investigation for COVID-19.

ESSENTIAL JOB FUNCTIONS:

The following duty statements are illustrative of the essential functions of the job and do not include other non-essential or marginal duties that may be required. The County reserves the right to modify or change the duties or essential functions of this job at any time.

- Determine need for allocation of COVID-19 vaccine to serve target population during each phase of vaccine distribution
- Performs rapid and PCR tests for COVID-19
- Will be responsible for assisting and sometimes leading COVID-19 vaccination clinics in Mineral County
- Responsible for submitting immunization data into CIIS for all COVID-19 immunizations administered by agency within 24-hours of vaccine administration
- Will check CEDRS (state communicable disease database)
- Will receive training on Dr. Justina app in order to have data viewing and entry capabilities for assisting with contact tracing and case investigation (CT/CI) for COVID patients and exposed contacts.
- Will attend regular meetings with state, regional and local partners to maintain situational awareness of COVID-19 protocols regarding but not limited to topics such as: epidemiological surveillance, testing, vaccine, isolation/quarantine etc.

 Works closely with Creede Family Practice, and Creede School District to provide advice and data for assessing COVID-19 safety measures and protocols.

- Ability to effectively assess client and community health needs.
- Ability to communicate both verbally and in writing in a clear and concise manner.
- Ability to effectively manage time.
- Strong communication and interpersonal skills.
- Mature judgment; ability to make quick and responsible decisions.
- Knowledge of current computer technology and ability to use or learn a variety of application software programs.
