Title: Application of OPCVC Community Safety Fund (2017/18)

Executive Summary

The Police Crime & Victims' Commissioner (PCVC) holds a budget that contributes to activities that are designed to make the community of County Durham and Darlington safer. In 2017-18 a proportion of that budget has been passed to the Safe Durham Partnership (County Durham geographic area), Darlington Community Safety Partnership (Darlington borough geographic area), and directly to other organisations for collaborative decisions on the application of the funding. The two partnerships – which include the OPCVC - are responsible for the decision making in respect of the funding in their geographic area. The OPCVC also allocated money from this budget directly to the Darlington Youth Offending Service (YOS) and North East Council on Addictions (NECA).

The attached table outlines how the funding is to be applied in 2017/18. The Safe Durham Partnership and Darlington Community Safety Partnership are subject to formal governance structures and the funding decisions are taken autonomously at their meetings.
