

MINUTES OF THE REGULAR MEETING OF TURTLE RIVER TOWNSHIP BOARD OF SUPERVISORS, THURSDAY, March 19, 2020 7:00 p.m., COMMUNITY CENTER

- 2. Sam Christenson made a motion to set the Road & Bridge levy at \$117,000. Bryan Campbell seconded. Motion carried 3-0.
- 3. Marie Kistler made a motion to set the General Levy at \$75,000. Bryan Campbell seconded the motion. Motion carried 3-0.
- 4. Bryan Campbell made a motion to raise the rental rates to \$50 a rental for township citizens and \$75 for non-township citizens, effective April 1, 2020 to newly scheduled rentals. Marie Kistler seconded the motion. Motion carried 3-0.
- 5. Sam Christenson made a motion to hire Jan Johnson as the new town hall scheduler, replacing Alvina Hasser, effective April 1, 2020. Bryan Campbell seconded the motion. Motion carried 3-0.
- 6. Bryan Campbell made a motion to raise the treasurer's monthly pay to \$500 a month. Marie Kistler seconded the motion. Motion carried 3-0.
- 7. Bryan Campbell made a motion to raise the townhall cleaning pay to \$75 a month. Marie Kistler seconded the motion. Motion carried 3-0.

B. READING OF BILLS AND CLAIMS:

Bills and claims #10123 to #10161 were presented for approval and payment in the amount of \$25,937.24. Sam Christenson made a motion, seconded by Marie Kistler, to pay the bills. Motion carried 3-0.
