# TURTLE RIVER TOWNSHIP ZONING BOARD ROAD TOUR May 4, 2023

The road tour began at 8:30 AM with Kent Porter, David Kloha, Diane Falk, Ann Nistler and Jan Johnson in attendance. The purpose of the tour was to look at those properties where land use permits were issued in 2022, look for new construction that did not secure a land use permit, and look for land use permit signs posted in the township.

We drove into the property on County Road 20 being used as a burrow mining site for reconstruction of County Road 20 and noted that it appears that the interim use permit requirements are being followed there.

The land use permit for Zach Graham, Parcel 48.00249.00, 10745 Birchmont Beach Road for a  $36 \times 60$  frame storage building was reviewed and the site visited. The building has been substantially started and work will continue.

The Rogers property was discussed for Parcel 48.00224.02 for a 24 x 32 dwelling. The concrete slab had previously been poured but no building has begun. They will need a new building permit if they continue with the project as the permit issued in 2021 has expired.

We drove by the Collins property. It does not appear that cleanup of the properties has taken place although junk and refuse has been moved around.

We looked at the property on Lamon Road where Port-a-Jon had dumped septic system material in 2022.

We passed by the Peder Johnson home on Lamon Road. This land use permit was issued in 2021 and is substantially complete.

We looked at the Finn property on Riverview Drive for which they have received a land use permit for a structure in 2023. Construction has not yet begun.

David explained to all that part of Elliot Road is split between Turtle River Township and Frohn Township.

We viewed the Matt Upgren home from Whitetail Drive. This land use permit was issued in late 2021 and the home is complete.

The Gary Lindseth property on Big Bass Road was looked at from the road. This land use permit was for a lean-to on an existing steel structure and is complete.

We drove by the Scott Watson property at 9034 Goodnuf Lane where the land use permit was obtained for a 16 x 80 mobile home. The mobile home is in place.

We visited the Casey Stone building site on Pincherry Road . The  $83 \times 48$  foot house and garage is complete.

The Zoning Road tour ended around 10:15 AM.

#### Minutes of the Regular Turtle River Township Zoning Board Meeting May 4, 2023

David Kloha called the meeting to order at 8:00 AM.

Citizens Input: Duane Erickson discussed division of property on Turtle River Lake into two parcels (Parcel A is 12.96 acres and Parcel B is 21.13 acres). The Beltrami County Recorder's office requested that he discuss this with the township to be sure there are no concerns on their part to this division. The Zoning Board found no problem with the division. Mr. Erickson will present this information at the next Board of Supervisors meeting.

David Kloha requested the reading of the April 6, 2023 Zoning Board meeting minutes. Kent Porter made a motion to accept the minutes, seconded by Ann Nistler. Carried.

Old Business: Ann Nistler needs to be reappointed to the Zoning Board by the Board of Supervisors retroactive to March 1, 2023 for a three year term. This request was not made at the March 2023 Zoning Meeting.

The Zoning Road Tour will take place immediately following the Zoning Meeting.

David received a call from a local appraiser asking that if a house burned down could it be rebuilt under the same guidelines of a previous ordinance. It was felt if the footprint did not change and it was rebuilt at the previous standards the new dwelling would be grandfathered in.

There was an inquiry regarding a Mark and Sally Rodgers property at 48.00224.02 on County Road 20. A land use permit was issued for this site (Permit # 562) with an after-the fact fee in 2021. No building has taken place since the permit was issued and that permit has expired. A new land use permit will be needed if there is going to be a structure placed at this site.

Jan Johnson read the building permits issued by Beltrami County in Turtle River Township for the month of April 2023. A building permit was issued to Rick Bowman, 13706 Jay Court, Parcel 48.00739.01, Gallagher Lake, for a 24 x 24 foot music room onto an existing single family building for \$80,000. One sanitary permit was issued in the township.

Karin Snortland indicated compensation rates are being reviewed by the Board of Supervisors. She also reminded everyone that the road/ditch cleanup is scheduled for this Saturday. If you receive calls from citizens regarding road damage caused by four wheel vehicles that the citizens should call the Sheriff's office.

The June Zoning Meeting has been rescheduled from June 1st to Monday, June 5th at 8:00 AM.

Diane Falk made a motion to adjourn the meeting at 8:30, seconded by Ketn Porter. Carried.
