## Representations and Warranties by the Stallion Owner/Agent:

1. I have the consent to nominate him in the Scottsdale Signature Stallion Auction and am subject to the General Rules & Regulations of the Signature Stallion Auction & Futurity.
2. I understand and warrant that by nominating the Stallion in the Scottsdale Signature Stallion auction, if there are no bids at the conclusion of the auction, I will be responsible for purchasing his breeding for \$1,100 paid by and no later than April 1 of the Auction year.
3. I hereby attest that all information listed within is true and accurate. I understand that failure to give accurate and truthful information on this form can result in possible disciplinary action by the AHAA Scottsdale Signature Stallion Committee and the Board of Directors of AHAA.
4. I the Owner/Agent of the Stallion will abide by the rules set forth to satisfy the breeding obligations sold at the Scottsdale Signature Stallion Auction.
5. I guarantee that all registration documentation required to register the resulting foal will be properly and promptly provided to the purchaser of the breeding.
6. I understand that the Breeding Agreement contains a live foal guarantee, which may mean that the breeding sold may have to be carried over to subsequent year(s).
7. In the event the stallion is injured or dies and is unable to fulfill this agreement, the breeding deposit will be refunded without interest, unless there is frozen semen available. If the stallion is sold, leased, or relocated within the United States of America prior to the conclusion of the breeding season, the original stallion owner, not the Purchaser, will be responsible for increases of fees and costs in breeding to the stallion in excess of those fees set forth in the Stallion Owners Breeding Contract, including but not limited to boarding and foaling fees, etc., and/or the costs of shipping semen. If the stallion is relocated outside of the United States of America, the breeding deposit may be refunded, without interest, to the Purchaser upon approval by the Arabian Horse Association of Arizona.

## Stallion Requirements:

1. Stallion owners will be required to donate one breeding each year of nomination to the Scottsdale Signature Stallion Auction, which will be auctioned off at the Scottsdale Arabian Horse Show. The breeding donated for each stallion will come with a live foal guarantee. This breeding can be carried over to future breeding years, but the nomination to the Auction class shall only be allowed for foals conceived in the year the breeding was purchased (some exceptions apply).
2. Stallion owner/agent must ensure that all breeding defects of the Stallion are included on Nomination Form and Breeding Agreement. Stallion owner/agent must also ensure that the Stallion is breeding sound.
3. If breeding is to be done by frozen semen only, such fact must be disclosed and Stallion owner must ensure that at least ten (10) straws of frozen semen will be available for this breeding.
4. Stallions must be nominated for each breeding year to participate. Stallion owner must fill out paperwork to nominate their stallions to be included into the specified breeding year and pay a \$500 nomination fee per stallion by November 15. Stallions will remain in the program unless AHAA is notified of any changes.
5. If breeding is not sold at the conclusion of the auctions the stallion owner/agent guarantees to purchase back the breeding for \$1,100. The SSS Committee at any point has the option to change the format of the auction for best success. All owner/agents by submitting a stallion agree to the direction of the SSS Committee.
6. Nominated stallions list is subject to change.
7. There is no limit to how many mares can be nominated into futurity to any one stallion.
8. Stallion owner agrees to comply with Scottsdale Signature Stallion Service Breeding Agreement rules and must honor fees that have been indicated on the agreement. If stallion moves to another barn or outside the country all fees indicated must stay the same.
9. If approved by AHAA Board of Directors stallion owners must honor a one-year carry-over of SSS Auction Breeding to stallion. Applicant wishing to carry over their auction breeding may only do so if the mare was bred and the breeding did not result in a pregnancy. Mare owner must submit a notarized vet's certificate/note stating mare was checked in foal but is no longer in foal (vets note must be notarized, year of breeding, stallion and mare names must be included). Stallion owner must submit a notarized letter stating the semen ship dates and record of breeding history for the breeding in question. All requests and notarized letters must be declared (received) by December 31 of SSS Auction purchase year stating that they would like to carry the Auction breeding over.
10. All decisions by AHAA Board of Directors will be final.
