Based on the experience, rice fortification will be gradually expanded to cover the entire rice distribution under PDS, and subsequently rice fortification can be made mandatory. Pilots on rice fortification under ICDS and MDM Schemes may also be undertaken.
- b) The Paper mentions that Decentralised fortification at intermediate level is the most preferred approach to rice fortification. Under this approach, fortification of rice can be done at district/ block level, especially fortification is done at milling points as it would save the additional cost of debagging of normal rice received at godowns and repackaging it after fortification.
- 3. The Approach Paper has been analysed. As per the Paper, the current FRK production is about 3600 tons per annum and thus rice fortification can be rolled out in a phased manner. Based on this, two options can emerge from the Action Plan, for your kind perusal.
- a) Roll out rice fortification in those States which have initiated rice fortification on pilot basis (Odisha, Karnataka, Andhra Pradesh, Maharashtra, Tripura).
- b) Initiate rice fortification on pilot basis in ICDS, MDM and PDS in the Aspirational Districts
- 4. As an immediate plan of Action, NITI Aayog can organise a Meeting with Department of Food, FSSAI, FCI, and Development Partners to discuss the following:
- a) Current offtake of FRKs and which States are consuming it.
- b) Identification of States and rice mills in the identified States for fortification of rice and bagging.

This is in reference to the Meeting that was held between the VC, NITI Aayog and World Food Programme on rice fortification in December, 2018 in which the VC, NITI Aayog suggested to have a Meeting with the Principal Secretaries, Department of Food and Civil Supplies of all 36 States/UTs to discuss introducing fortified rice under Public Distribution System (PDS).

- 2. Accordingly, a Consultation Meeting was held under the Chairmanship of Vice-Chairman, NITI Aayog with the Secretary and senior officials from Department of Food and Public Distribution and the senior officials from Department of Food of various State Governments on 16.01.2019 to discuss the Pilot Scheme on Rice Fortification under PDS. The list of participants is attached in correspondence.
- 3. Different presentations were made by Department of Food and Public Distribution (DoF); FSSAI; Food, Civil Supplies and Consumer Protection Department Civil Supplies and Consumer Protection Department, Government of Maharashtra; Department of School & Mass Education, Government of Odisha; and World Food Programme (WFP) on different aspects of rice fortification. The presentations are attached in correspondence.
- 4. After detailed deliberations with the State officials, representatives from DoF and other stakeholders, the following decisions and recommendations were made:
 - The DoF may examine and incorporate the suggestions and inputs given by the State Governments and accordingly revise the SFC note. The DoF may also consider alternative models of blending, apart from the European model, and accordingly revise the capital cost of blending machines in the SFC note.

- The total cost of the Scheme covering all Districts is around Rs.2437 crores. Consideration of providing 100% funding by Government of India for the Scheme may be explored.
- Since the Scheme has the potential for improving nutritional outcomes of the population in a significant way, NITI Aayog recommends that the Scheme on rice fortification under PDS should have an enhanced coverage across India, covering both DCP in the Phase I and non-DCP States in Phase II. To achieve the same, adopting a 2 pronged Strategy is recommended- a) In the non-DCP States, fortification at the point where rice is produced and collected may be explored. The role of FCI and the Department of Food and Public Distribution for its successful implementation is critical and needs to be emphasized; and (b) In the 15 DCP States, rice fortification to be continued and scaled up with the support of State Governments.
- FSSAI to focus on Information, Education and Communication (IEC) and create demand generation for fortified products.
- FSSAI should focus on creating a robust Quality Control and Assurance for fortified rice.

This is in reference to the Operational Guidelines Centrally Sponsored Pilot Scheme on "Fortification of Rice & its Distribution under Public Distribution System" shared by Department of Food and Public Distribution had shared the Operational Guidelines on dated 10.04.2019 and requested NITI Aayog for comments on the same. The Office Memorandum and the Draft Operational Guidelines are attached as correspondence, for your kind reference.

- 2. NITI Aayog has examined the Draft Guidelines. The Operational Guidelines are very comprehensive and detailed and there is an in-principle agreement with the Guidelines. The main observations are as follows:
 - DOFPD should coordinate with FSSAI to define the technical specifications for fortified rice including fortified rice kernel (FRK) used to fortify rice and include it in the Food Safety and Standards (Food Products Standards and Food Additives) Regulations, 2011. This will enable policy makers to make policy decisions related to introducing fortified rice through public sector programs like PDS, MDM and ICDS.
 - 2. It is suggested that the quality parameters pertaining to fortified rice should be included as an additional parameter under schedule of specifications mentioned under the "Uniform Specifications for Grade A & Common Rice". This will facilitate state governments to procure fortified rice adhering to the FCI specifications and quality norms.
 - 3. Developing comprehensive Plan for Training and Capacity Building is crucial especially related to quality control and assurance.
 - 4. It is suggested that indicators may be defined for the monitoring and periodic evaluation of the Scheme.
 - 5. DoFPD may consider conducting a midline evaluation to understand if the Scheme is in the right path and suggest corrective measures, if any.

- 2. The proposed Universal Central Sector Scheme is a continuation of the Centrally Sponsored Pilot Scheme on Rice Fortification under PDS with the same components of the Pilot Scheme, i.e. institutional, costing (at 60p/kg), supply chain structure, capacity building, IEC strategy, quality control and assurance, and monitoring and evaluation. NITI Aayog has already shared its comments on the SFC note and Operational Guidelines of the Pilot Scheme on Rice Fortification Scheme.
- 3. The Scheme would be a Central Sector Scheme i.e. 100% funded by the Government of India. The Scheme has been proposed to be implemented from 2023-24. The total cost of the Scheme is estimated to be around Rs.2359 crores per annum.
- 4. NITI Aayog has prepared the comments on the draft EFC note and the team even consulted Vice-Chairman, NITI Aayog on the same. The main highlights of the comments are as below:
 - It is recommended that to launch the Universal Scheme on Rice Fortification under PDS by 2020-21. The Scheme maybe implemented in phases, covering High Burden Districts on anemia (as per NFHS IV) in the first year,i.e. 2020-21 and pan-India roll out by 2021-22.
 - A roadmap and annual targets maybe developed for its phased implementation
 - It is recommended that flexibility in the modality of FRK procurement maybe given to the States/UTs- procurement of rice millers from Rice Millers or procurement of rice millers from the State/UTs.
 - It is recommended that Third Party evaluation should be conducted to assess the baseline and impact assessments of the outcomes.

The comments of G&R vertical are as under:-

- 1. Given the incidence of anaemia and micronutrient deficiency and the fact that the pilot projects in select districts have exhibited encouraging results, the proposal deserves full support of NITI Aayog. However, we may need to expedite the project to enable universal roll out by 2021-22 instead of 2023-24 proposed by the Department of Food and PD. Prior to this, the pilot project may be expanded to cover all aspirational districts and districts suffering from high incidence of anaemia and micronutrient deficiency by 2020-21 itself.
- 2. One of the major bottleneck in universal expansion appears to be limited availability of FRK within the country as supply at current level of production capacity is 10,000 tonnes whereas requirement at full scale implementation for 35 million tonnes (of supply of rice under PDS, MDM, ICDS, etc.) is about 3.5 lakh tonnes. Nevertheless, this need not constraint towards early universalisation of the project as we can always resort to imports of FRKs. A phased plan for meeting FRK requirements through imports and quickly expanding domestic production may be chalked out by DFPD in coordination with Department of Commerce, DPIIT, FSSAI (FFRC), concerned industry associations and other stakeholders.
- 3. In the pilot project, the sharing pattern envisaged was 90:10 for NE States & Sikkim and 75:25 for other States. However, in the proposed EFC note, 100% cost is to be borne by the Centre. This may need to be re-examined.
- 4. Under National Food Security Act, 2013, issue prices (Rs.1/2/3 per kg for coarsegrains/ wheat/ rice) were to be frozen for a period of 3 years and a revision could be made after July 2016. However, for various reasons, the prices have remained frozen. It is high time that the Department takes a thorough review of issue prices which can potentially save Rs.50,000 crore a year of food subsidy (actual allocation Rs.1.84 lakh crore for 2019-20). At least for non-AAY beneficiaries, the issue prices could be raised to about Rs.8-10 per kg, which is also broadly in line with the actual issue prices prevailing for APL families prior to enactment of NFSA.
- 5. While revision of issue prices under NFSA is a decision to be taken separately from the current proposal of fortification of rice, it is proposed that, to begin with, the cost of fortification of about Rs.0.60 per kg may be passed on to the beneficiaries.

With this, the entire cost of Rs.2,359 crore <u>need not be</u> borne by the Centre or the States/ UTs. It may be mentioned that economic cost of rice for 2019-20 is estimated at Rs.36 per kg while issue price is just Rs.3 per kg. Increasing issue price by Rs.0.60 per kg should not be that difficult and can be borne by the consumers.

- 6. This being an important initiative as part of Poshan Abhiyan, it is proposed that a system of concurrent evaluation may also be put in place. Besides, to begin with, a quick assessment of districts where pilot project is running, may be undertaken which can provide useful inputs for expanding the project on the national scale.
- 7. Views of State Governments may also be taken before expanding the project on the national scale.

2. Approval sought

- i. Approval of EFC is solicited for universal roll out of the Scheme for Fortification of Rice and its Distribution under PDS all over Inida, involving an estimated cost of Rs. 2359 crore for implementation from the year 2023-24. This scheme is proposed to be 100% funded by the Government of India.
- ii. It is proposed that the incremental cost of the Fortification of Rice and its Distribution under PDS, is to be added as an incidental expenditure in Provisional Cost Sheet for procurement of Paddy at the rate of the cost at 60 paisa per kg+ administrative charges in term of rice under food subsidy. The budget will be accordingly provided to the State/FCI as subsidy under National Food Security Act, 2013.

3. Background

The current proposal is for seeking in-principal approval for the Universalisation of Fortification of Rice and its Distribution under PDS and OWS to put in place a new road map for addressing the problem of anaemia and micro-nutrient deficiency in the country. Presently, a pilot project on Fortification of Rice and its Distribution under Public Distribution System (PDS) and Other Welfare Schemes (OWS) is being implemented in 15 selected Districts for a period of 3 years beginning from 2019-20. Universalisation of this Scheme will be in continuation of the recently approved Pilot Scheme and has been proposed to be implemented from 2023-24 onwards.

PART II: Comments of NITI Aayog

PAMD Comments

- 1. The problem of anaemia is widespread in India across young children, women and men. The EFC memo states that around 58.5% of young children (6-59) months, 53% of women in the reproductive age group and 22.7% of all men aged 15-49 years of age suffer from anaemia. Strategies to address anaemia and micronutrient malnutrition in Indian population being addressed through PDS/MDM/ICDC etc. include dietary diversification, food fortification, nutrition and health education, supplementation etc. The EFC memo states that 65% of the population consumes rice as a staple food across all population groups in India. Fortification of rice is a cost-effective strategy to increase vitamin and mineral content of diets and is expected to address the gap in nutritional needs. NITI Aayog fully supports the proposal.
- 2. The National Food Security Act, 2013 (NFSA) that came in to force in July 2013 seeks to provide food and nutrition security by ensuring access to adequate quantity of quality food at affordable prices. States/UTs will be responsible for distribution of fortified rice as part of PDS and Food Corporation of India (FCI) and States/UTs will be responsible for fortification of rice procured during MSP operations.
- 3. In order to ensure efficient utilization as well as distribution of food-grains it is imperative that the distribution of food-grains under NFSA is undertaken under PPP mode. This shall ensure cost-effective procurement without leakages, timely distribution

as well as proper storage to avoid deterioration of food-grains. Existing systems adopted by FCI/ other state agencies suffers from various issues such as leakage, inclusion/exclusion errors and high cost of transportation/storage. It is necessary to radically overhaul the existing systems to ensure efficiency and positive impact to the beneficiaries. This can be achieved by adoption of public private partnership (PPP) models in procurement as well as public distribution system. Private players should be engaged for procurement, transportation and storage of identified quantum of food grains for operational purposes as well as for maintenance of buffer stock in identified areas or at state/national level. Similarly distribution of food grains under TPDS can be undertaken through private players procuring food grains/ or through other specialised agencies to ensure efficiencies and economies of scale This shall ensure long term sustainability through lower dependence on/requirement of subsidy as well as for better service quality to beneficiaries. Engagement of private players shall also ensure use of automated systems/technologies for better assessment of required quantum of foodgrains, procurement of optimal quantities and inventory management. Therefore it is recommended that PPP models are formulated and adopted for suitable impact and efficient use of public resources.

- 4. Presently, 350 lakh MT of rice is being distributed in the country under TPDS/OWS. To fortify this entire quantity of rice allocated before lifting, a minimum supply of about 3.5 lakh metric tonnes of Fortified Rice Kernel (FRK) would be needed. However, the present supply of FRK in the country is around 10,000 MT. Initiatives to augment the supply of FRK in a short time to meet the requirements of the proposed scheme are required. The Department may furnish its plan to meet the huge deficit in supply of FRK and ensure timely provision of fortified rice to the beneficiaries.
- 5. The EFC memo states that the incremental/operational cost of production of fortified rice is 60 paisa per Kg of fortified rice. Cost estimates of producing 350 LMT of fortified rice would annually be about Rs. 2359 crore in the year 2023-24 which is inclusive of other expenses such as CPMU, SPMU etc. The cost of Rs. 0.60 per kg. is proposed to be added as an incidental expenditure in Provisional Cost Sheet for procurement of Paddy. However, the base date/year of the cost estimates has not been indicated.
- 6. It is suggested that Universalisation of the Scheme may be taken up in phases and may be started within a year of functioning of the pilot project i.e. from 2020-21 onwards. The experiences from the pilot project may be recorded concurrently and used to improve the implementation of the Scheme in all States/UTs. Aspirational Districts and those with a relatively poorer performance in health and nutritional indicators may be given preference in terms of implementation of the scheme.
- 7. As per para 4.1 of the EFC memo, for the blending of fortified rice, the miller is required to make investment in procurement of additional equipment. The Department should ensure that the Millers receive adequate support in procuring, setting up and for operation of the blending machine. The quality of the final product, i.e. the blended rice may be examined to ensure it meets all the standards laid down by FSSAI.

SMD Comments (WCD)

8. It is recommended that to launch the Universal Scheme on Rice Fortification under PDS by 2020-21. The Scheme may be implemented in phases, covering High Burden Districts

on anaemia (as per NFHS IV) in the first year, i.e. 2020-21 and pan-India roll out by 2021-22.

- 14. In the pilot project, the sharing pattern envisaged was 90:10 for NE States & Sikkim and 75:25 for other States. However, in the proposed EFC note, 100% cost is to be borne by the Centre. This may need to be re-examined.
- 15. There is already a case for revision of central Issue prices under NFSA which have been frozen at Rs. 1/2/3 per kg for coarse grains, wheat and rice for a long time. To begin with, it is suggested that the cost of fortification of about Rs.0.60 per kg may be passed on to the beneficiaries. With this, the entire cost of Rs.2,359 crore need not be borne by the Centre or the States/ UTs. It may be mentioned that economic cost of rice for 2019-20 is estimated at Rs.36 per kg while issue price is just Rs.3 per kg. Increasing issue price by Rs.0.60 per kg should not be that difficult and can be borne by the consumers.
- 16. This being an important initiative as part of Poshan Abhiyan, it is proposed that a system of concurrent evaluation may also be put in place. Besides, to begin with, a quick assessment of districts where pilot project is running, may be undertaken which can provide useful inputs for expanding the project on the national scale.
- 17. Views of State Governments may also be taken before expanding the project on the national scale.

This is in reference to the Letter to Vice-Chairman, NITI Aayog by Mr. R.S Sondhi, Managing Director, Gujarat Co-operative Milk Marketing Federation Limited regarding Mass Vitamin Fortification using synthetic Vitamins. The letter is attached as Correspondence, for reference.

- 2. The letter includes a brief note on natural vitamins and Amul's stand point on Mass Vitamin Fortification using synthetic Vitamins, based on technical literature reviews on various studies on effects of synthetic vitamin supplementation on humans. The summary of the note and their stand point is as follows:
 - Milk fortification with vitamin A and D (fat soluble) is not sufficient (only 10% is sold as market milk by organized sector) and problem will not address the issues of deficiencies. (WHO does not consider milk as good vehicle for Vit A fortification)
 - Synthetic fortification can have toxic effects which are a reversible in the long run that is if there is continuous exposure .
 - Synthetic vitamins are look alikes of natural vitamins
 - Synthetic vitamins are crystalline in nature (not dissolve and get accumulated and pose health risk) and natural ones in fruits and vegetables are amorphous in nature. However fortification with beta-carotene or pro vitamin carotenoids does not result in toxicity Vitamin D through Dietary supplementation is not justifiable as overexposure has toxic effects which can damage heart lungs and kidneys
 - Vitamin A fortification in margarine vegetable oils, sugar, rice and cereals is found to be efficacious

- In absence of Quality Assurance Program and testing of added Vitamin A&D in various foods at the factory level/ plant level, it is risky to start mass fortification.
- Vitamin A&D in Milk should be voluntary and regulated and not mandatory Promote natural vitamins rather than synthetic vitamins in fortificatio n.
- 3. In view of the above note, it is suggested that in order to give any policy recommendation on Mass Vitamin Fortification, the Study maybe reviewed and evaluated by a technical organisation like Indian Council of Medical Research (ICMR) or any technical committee of scientists from the concerned field.

This is in reference the OM, File No.15-1/2017-BP-II, dated 14.11.2019 regarding the request by Department of Food and Public Distribution for comments on draft SFC Note on Revision in Pilot Scheme for "Fortification of Rice and its Distribution under Public Distribution System". The Revised SFC note is attached in correspondence.

- 2. The current SFC note has the following revisions:
 - i. Based on the rate of FRK quoted by different States for the Pilot Project, the average price for FRK is indicated to be Rs. 68.79 per kg instead of the earlier derived estimated FRK cost of Rs. 55.04 per kg.
 - ii. Keeping in mind the revised cost of FRK at Rs. 68.79, the incremental cost of fortified rice is now rounded off to be Rs. 0.73 per kg as against the provisional approved rate of Rs. 0.60 per kg.
 - It is also proposed that F CI will carry out a scientific study on the shelf life of fortified rice and the added minerals and vitamin potency in the FRK after its storage period. A provision of Rs.1.54 crore has been proposed for this study.
 - As the establishment of the Central Project Monitoring Unit and State Project Monitoring Unit for 15 States is still under process, there will be lesser expenditure on this component and the saving of Rs.2.60crore is estimated, from Rs.5.07crore.
- 3. In view of the above, the total estimated outlay of the Pilot Scheme from 2019-2022 is revised to Rs.174.64crore, from the existing Rs. 147.61crore.

(Incremental cost of producing fortified rice is Rs.28.09cr + Study on shelf life at Rs.1.54cr – CPMU/SPMU cost at Rs.2.60crore)

4. NITI Aayog's Comments:

The revised SFC note on the Pilot Scheme for "Fortification of Rice and its Distribution under Public Distribution System" has rightly taken into account the high prices of FRK quoted by the States in their tender. The comments on the revised draft SFC note are as follows:

1. The Scheme has a component on Monitoring and Evaluation "*Third party evaluation involving a baseline and end-line would also be conducted*". Therefore, it is suggested that DoFPD may initiate baseline survey in all the Pilot Districts against which the endline will be evaluated.

- 2. While the revised SFC note rightly takes into account the high initial prices of FRK, however, it is expected that the Pilot Scheme will be rolled out in all the 15 Districts by its second year that will significantly enhance the demand of FRKs. In view of this, it is expected that the price of FRKs is likely to reduce on reaching economies of scale. Thus, it is recommended that the estimated incremental cost of fortified rice needs to be evaluated at the end of first year and the budget estimates maybe revised accordingly.
- 3. It is recommended to expedite the establishment of Central Project Monitoring Unit at the Ministry level and the State Project Monitoring Unit in those States where the Scheme has been initiated. Timeframe of the establishment may be provided.

2. The draft EFC note proposes rolling out fortification of rice with Iron, Folic Acid and Vitamin B12, in TPDS under NFSA, ICDS and MDM in all States and UTs in phased manner from 2021-22. It is a continuation of the Pilot Scheme on Rice Fortification under PDS, launched in 2019 which was designed to cover 15 Districts.

- 3. The total incremental cost towards procurement of fortified rice, when the blending operations are done at rice mill level, for supplying under TPDS/ICDS/MDM above is estimated to be approximately Rs. 2810 crore annually in the first year of the initiative. The proposed initiative is a Centre Sector Scheme, implemented by Department of Food and Public Distribution through FCI/State Agencies and will be fully funded by Government of India. It is proposed that the annual additional cost of rice fortification will be subsumed in the annual food subsidy bill of DoFPD. The draft EFC also proposes to consider fixing the Central Issue Price of Fortified Rice for TPDS/ ICDS/ MDM at Rs.4/kg.
- 4. WCD Division of NITI Aayog has examined the draft EFC note. The comments on the same are mentioned briefly below:
 - The Draft EFC recommends a third party evaluation of the proposed initiative. However, as monitoring and evaluation is crucial to understand the efficacy and impact of the proposed initiative, it is suggested that a baseline maybe undertaken in the randomly selected Districts to measure the impact of rice fortification. A national level dashboard maybe developed for smooth monitoring of the proposed initiative in a timely manner.
 - Comprehensive Operational Guidelines will be necessary to detail out the action plan for various components of the proposed initiative like capacity building of different relevant stakeholders, quality control and assurance, IEC and demand generation and so on.
 - DoFPD may pursue with FSSAI to expedite on **defining the technical specifications for fortified rice including fortified rice kernel** (FRK) and including it in the Food Safety and Standards (Food Products Standards and Food Additives) Regulations, 2011.
 - **Efficient tracking mechanism** including barcoding of fortified rice bags may be explored by DoFPD to ensure better its tracking and last mile delivery to the FPS.
 - DoFPD may persue with FSSAI to scale up and strengthen the NABL accredited labs in the States for smooth quality control and assurance of the proposed initiative.
 - The 250 malnourished Districts may be re-worded as High Burden Districts as the same nomenclature was used for POSHAN Abhiyaan as well. POSHAN Abhiyaan was rolled out in a phased manner where it was first implemented in 315 High Burden Districts on stunting based on NFHS-4 data. 250 High Burden Districts on stunting based on NFHS-4 data is attached as annexure, for reference.
- 5. With these comments, in-principal approval has been accorded to the draft EFC note.

- 1. FR (page 726-749/c) is a Status Update Report from WFP regarding implementation of the Centrally Sponsored Pilot Scheme for Distribution of Fortified Rice through the Public Distribution System in 15 States in India.
- 2. Centrally Sponsored Scheme for Distribution of Fortified Rice through PDS: In 2019, the Department of Food and Public Distribution, Government of India has launched a three-year pilot on the Centrally Sponsored Scheme for Distribution of Fortified Rice through the PDS in 15 Districts across 15 States. The Pilot Scheme focuses on 15 Districts, one per state in Assam, Andhra Pradesh, Odisha, Kerala, Karnataka,

Maharashtra, Uttar Pradesh, Gujarat, Tamil Nadu, Telangana, Punjab, Chhattisgarh, Jharkhand, Madhya Pradesh and Uttarakhand.

3. In 2020-21, the annual distribution of rice is:

- 4. So far, distribution of fortified rice through the PDS is taking place in 6 States out of 15 States:
 - i. Gujarat
 - ii. Maharashtra
 - iii. Chhattisgarh

 - vi. Andhra Pradesh

Distribution is expected to start soon in Odisha, Kerala, and Jharkhand.

6. Challenges in the implementation of the Pilot Scheme:

- i. **Inadequate FRK Supply to cover all of PDS, MDM and ICDS**: Current capacity of FRK production is 30,000 MT/year, against an annual demand of 3.5 lakh MT. However, with more rice millers willing to setup FRK plants in the near future, the situation of inadequate numbers of FRK suppliers is expected to be resolved soon.
- ii. Lack of well-defined monitoring mechanism by Department of Food and Public Distribution
- iii. Lack of standardization at NABL Laboratory level
- iv. Lack of compliance towards quality control/quality assurance protocols during the process of production of fortified rice by rice millers.
- v. Lack of will, capacity and supervision by State FPD Departments;
- vi. COVID-19 and elections/ transfer of officials further delaying the process.

7. Way Forward Suggested by the Report:

- Scale up of distribution of fortified rice in ICDS/MDM in all States in 2021-22
- ii. Government should consider providing a subsidy to support rice millers and small cooperatives for establishing fortification related infrastructure
- Strengthen quality control protocols at the rice mills and FCI, through development of technical capacities and sensitisation of millers and State officials
- iv. **High GST on fortified rice kernels (18%)** and high cost of premix is another factor which inhibits investment of private organisations in fortification market. Government may consider lowering the GST band applied on fortified rice as it is largely meant for supply in food subsidy scheme.
- v. Building the capacities and infrastructure to support NABL labs in the country
- vi. Instituting mechanism for **monitoring and evaluating** the quality aspect of the scheme.

8. NITI Aayog's Role in facilitating the implementation of the Pilot Scheme:

As the country is suffering from the negative impacts of the pandemic on the nutrition of the vulnerable population and as NFHD-5 has demonstrated deteriorated nutritional outcomes (Stunting, wasting, anaemia, and underweight), the importance of fortification cannot be over emphasized as a very critical strategy to improve the nutritional outcomes of these population.

8.1. Organise a Meeting under the Chairmanship of VC/CEO with all the Pilot State Participants, DoFPD, FSSAI and Development Partners to:

- To learn from the success stories of those which implemented the Pilot Scheme
- To expedite the distribution of Fortified rice in those 9 States where the distribution has not yet started.
- Implementing the distribution of fortified rice atleast in the Aspirational Districts on a priority basis.
- Resolving the other issues like instituting monitoring and evaluation mechanism, strengthening the capacity of NABL labs, GST on FRKs etc.
- 8.2. VC may send D.O. Letters to the Chief Ministers of those States which have not initiated the pilot Scheme to expedite the process soon.

- 1. FR (page 771-772/c) is DO No 15-1/2017-BP-II (Pt.) (E-337997) Dated 12.07.2021 from Secretary, Department of Food & Public Distribution regarding fortification of rice and its distribution under PDS.
- 2. Centrally Sponsored Scheme on "Fortification of Rice & its Distribution under Public Distribution System" was launched for a period of three years beginning in 2019-20 with total outlay of Rs 174.64 Cr in 15 districts of 15 States Governments. So far six States- Andhra Pradesh, Gujarat, Maharashtra, Tamil Nadu, Chattisgarh and Uttar Pradesh have started distributing fortified rice under the scheme in their identified districts.
- 3. NITI Aayog played a key role in roll-out the above mentioned pilot schemes. VC, NITI Ayog, Member (H) and CEO held various consultation with the Ministries, States/UTs and development partners in this regard. Later, NITI Aayog has shared a note on Universalisation of Rice Fortification under PDS and offered comments on Draft EFC on Universalisation of Fortification of Rice and its Distribution System (PDS) and Other Welfare Schemes (OWS). (Note#109) VC and CEO, NITI Aayog wrote DO letters to all States Governments/UT Administrations on the importance of rice fortification to encourage them to initiate rice fortification in their States. (page 390/c and page 388/c).
- 3. For scaling up fortification, DoFPD has proposed EFC for supply of fortified rice throughout the Targeted Public Distribution System (TPDS) under the National Food Security Act (NFSA), ICDS and MDM in all States/UTs in a phased manner. However, before going ahead with the EFC, Hon'ble Minister of Consumer Affairs, Food and Public Distribution desired a presentation on this initiatives of fortification of rice, duly considering inter alia scientific validations, alternatives etc. A copy of draft presentation sent by DoFPD may be seen at page 773-778/c
- 4. Secretary, DoFPD has requested NITI Aayog to present a unified strategy after taking into account the study reports of various institutions and to conceptualize an evaluation design for outcomes of this nutritional intervention. Finally, a request for presentation by NITI Aayog for the Hon'ble Minister has been made.

- 5. On 23.07.2021, a meeting under the Chairmanship of Hon'ble Shri Piyush Goyal, MFPD was organised and CEO, NITI Ayog made a presentation (page 801-821/c) for universalisation of rice fortification. Member(Health) and Member (Agri) pitched for rice fortification as an effective instruments for combating anemia. AS (H&N) was present in the meeting. Higher Officials of MoFPD, FCI, FASSAI etc were deliberated on the issue of rice fortification in the meeting.
