# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to http://naturalstateaesthetics.com, and Natural State Aesthetics and governs data collection and usage. ### **Collection of your Personal Information**

# **Sharing Information with Third Parties**
