# ETRAINETC, LLC SOFTWARE END USER LICENSE AGREEMENT

YOU SHOULD CAREFULLY READ THE FOLLOWING TERMS AND CONDITIONS BEFORE USING THIS PRODUCT. BY CLICKING THE ACCEPTANCE BUTTONYOU ARE CONSENTING TO BE BOUND BY AND ARE BECOMING A PARTY TO THIS AGREEMENT.

This Agreement sets forth the terms and conditions of your use of the accompanying product and services (the "Software" as defined below). For the purposes of this Agreement, "you" means you, the Subscriber or the Authorized User, and "Licensor" means eTrainetc, LLC and its subsidiaries and affiliates.

# 1. Definitions.

- (a) "End User Product" means an Output File, which contains the eTrainetc, LLC Run-Time, knowledge, knowledge application, knowledge confidence, assessments and all applicable data analytics and reporting generated by you. Examples of End User Products include any HTML, JS files used for courses, authoring tools, demonstration files, interactive multimedia material, interactive entertainment products, and the like.
- (b) "Output File" means an output file generated by you using the Software.
- (c) "Software" means the Licensor's software program(s) including the Platform, Library and any pre-developed Modules and third party software programs, in each case, supplied by Licensor herewith, and corresponding documentation, associated media, printed materials, and online or electronic documentation. Any updates to such Software that has been provided to You by Licensor shall also mean Software for purposes of this Agreement.
- (d) "Library" refer to the eMicroSim Library which provides storage for both custom developed and pre-developed Modules, and User Materials to Subscribers.
- (e) "Platform" refers to the eAuthor1 Platform which enables the Subscriber to custom develop Modules or use pre-developed Modules to create their End User Product.
- (f) "Module(s)" refers to both the custom developed and pre-developed, industry-specific simulations, applications, and assessments created and accessed using the Software.
- (g) "Application Services via Internet" refers to the actual setup and process of this Software. The Software is run on the user's device (e.g., personal computer, portable computer, personal digital assistant, smart phone, etc.) but accesses Licensor's server via the internet.
- (h) "User Materials" refers to any materials provided by you including but not limited to company product documentation, images, video, etc. User Materials are stored on their own network or desktop.
- (i) "Trial Version" refers to the seven-day free trial version of the Software that may be accessed by Subscribers interested in testing out the Software.
- (j) "Subscriber" refers to the entity that is accessing the Trial Version of the Software for purposes of testing out the Software and determining if they are interested in entering into a Master Subscription Services Agreement with Licensor.
- (k) "Authorized User" means any person designated to access and use the Software or Third Party Software through the Subscriber.

#### 2. License Grant.

(a) Licensor hereby grants to you a non-exclusive and non-transferable license to use the Software and related documentation (the "Documentation") solely for the intended purposes of the Software as set forth in the Documentation, according to the provisions

contained herein and subject to payment of applicable license fees. You may use the Software on any internet-enabled device. You are not permitted to lease, rent, distribute, sublicense, or make the Software available over a network where it could be used by multiple devices at the same time. You may not share, install, or use the software concurrently on more than one computer. You also may not use the Software in a time-sharing arrangement or in any other unauthorized manner. Except for the limited license granted herein, Licensor expressly reserves all other rights to such patents, copyrights, trade secrets, trademarks, or any other intellectual property rights in the Software.

You agree that you have no right, power, or authority to make any modifications to or unauthorized copies of the Software.

- (b) In the event the Software is distributed along with other software products of Licensor as part of a suite of products, the license of the suite of products is licensed as a single product and none of the products in the Suite, including the Software, may be separated for installation or use on more than one computer.
- (c) You may make copies of the End User Product, and any and distribute those copies; provided however, that (i) Software may not be distributed or used other than as bundled with the Output File as part of the End User Product, and (ii), you shall require each party to whom the End User Product is distributed to agree that no title to, or ownership rights in, the Software are transferred and that the End User Product, including any associated products, shall not be reverse compiled or disassembled. In addition, you may not distribute an End User Product for the purpose of which is to replay the courseware, presentations, interactive multimedia material, interactive entertainment products and the like of others.
- (d) You agree that Licensor may audit your use of the Software for compliance with these terms at any time, upon reasonable notice. In the event that such audit reveals any use of the Software by you other than in full compliance with the terms of this Agreement, you shall reimburse Licensor for all reasonable expenses related to such an audit in addition to any other liabilities you may incur as a result of such non-compliance. Licensor reserves the right to terminate your License for such noncompliance at their discretion.
- (e) If you are a Subscriber accessing the Trial Version and unless otherwise set forth in the documentation relating to such code and/or the Software or in a separate agreement between you and Licensor, You may only modify the source code form of those portions of such software programs that are identified as Sample Code, Sample Application Code, or Components (each "Sample Application Code") in the accompanying documentation and solely for the purposes of designing, developing and testing Modules developed using the Software; provided, however, that you are permitted to copy and distribute the Sample Application Code (modified or unmodified) only if all of the following conditions are met: (1) you distribute the compiled object Sample Application Code with your proprietary code; (2) you do not include the Sample Application Code in any product or application designed for website development and (3) you do not use Licensor's name, logos or other Licensor trademarks to market your proprietary code.

# 3. Restrictions.

- (a) Other than as set forth in Section 2, you may not make or distribute copies of the Software, or electronically transfer the Software from one computer to another or over a network.
- (b) **No Assignment; No Transfer.** You may not transfer or assign the Software or rights under this Agreement.
- (c) **No Modification; No Reverse Engineering.** You shall not, nor permit others to modify, translate, reverse engineer, decompile, disassemble, or create derivative works of the Software or assist someone in performing such prohibited acts. Any attempt to do so is a violation of this Agreement and of the rights of Licensor. If you violate this restriction, you may be subject to prosecution and damages.

- (d) Subscriber Restrictions. Unless otherwise provided for herein, You shall not (A) in the aggregate, use more than one copy of the Trial Version, (B) use the Trial Version under more than one Username, (C) alter the contents of a hard drive or computer system to enable the use of the Trial Version for an aggregate period in excess of the trial period for one license to such Trial Version, (D) disclose the results of software performance benchmarks obtained using the Trial Version to any third party without Licensor's prior written consent, or (E) use the Trial Version for a purpose other than the sole purpose of determining whether to purchase a license to the Software; provided, however, notwithstanding the foregoing, you are strictly prohibited from using the Trial Version for any commercial purpose.
- (e) **Protection and Security.** You agree not to disclose, publish, release, transfer, or otherwise make available the Software or any portion thereof, in any form, to any person, other than an Authorized User without prior written consent from Licensor. You agree that the Software is the property of and proprietary to Licensor, and further agree to protect the Software and all parts thereof from unauthorized disclosure and use by your agents, employees, or customers. You shall be exclusively responsible for the selection, supervision, management, control, and use of the Software. You agree to utilize your best efforts or see that your employees or any other user, including any Authorized User of the Software complies with the terms and condition of this Agreement and refrains from taking any steps, such as reverse assembly or reverse compilation, to derive a source code equivalent of the Software. If the Software is compromised under your license/serial number, your account will automatically be disabled. You will be notified by email of the problem and be required to contact Licensor for security reasons. (We have the ability to map the code by individual computer signature. If the license key turns up on another computer, access is denied to all.)
- (f) **Import/Export Restrictions.** You agree not to import or export the Software or any Documentation (or any copies thereof) or any products utilizing the Software or any Documentation in violation of any applicable laws or regulations of the United States or the country to which you have imported or exported. You agree to indemnify Licensor from liability if you violate any such laws or regulations.
- (g) You agree that you will not knowingly use the Software in any manner which may infringe copyright or intellectual property rights or in any manner which is unlawful, offensive, threatening, libelous, defamatory, pornographic, obscene or in violation of the terms of this Agreement. Further, you will not use the Software in such a way that breaches any duty of confidentiality that you owe to another person or entity. - **4. Upgrades.** Licensor may make upgrades to the Software at their discretion. The provisions of this Agreement shall apply to any and all future upgrades unless otherwise modified by Licensor.
- 5. License Fees. (If Applicable) You agree to pay Licensor prior to or concurrent with delivery of the Software the full license fee agreed to upon ordering the Software. A warning will be issued based on your monthly fee fifteen days (15 days) prior to disconnection. Any payment not made when due shall accrue interest at the rate of two percent (2%) per month. In addition, you agree

to pay Licensor any and all applicable tax that is levied in conjunction with the purchase of this License for the Software whenever Licensor must collect and/or pay such taxes from or on behalf of you according to the applicable statutes and ordinances, as interpreted by the departmental authority of the taxing unit. Furthermore, you agree to pay Licensor all costs, expenses, and attorney's fees expended by Licensor in the collection of the purchase price, whether by filing a lawsuit or otherwise. If you are utilizing a Trial Version, your License under this Agreement will automatically terminate within seven days from you first access to the Software unless you execute a Master Subscription Service Agreement and pay the applicable license fees associated.

- 6. Title. You agree that Licensor owns and holds title to the Software and any Documentation and all subsequent copies thereof regardless of the form. Furthermore, title, ownership rights, and intellectual property rights in the Software and any Documentation shall remain with Licensor. The Software and any Documentation are protected by copyright and other intellectual property laws and by international treaties. All rights in the Software and the Platform not expressly granted hereunder are reserved to Licensor.
- 7. Term and Termination. Licensor may terminate the License granted under this Agreement at any time for any reason. You agree that you will not be entitled to a refund of any applicable license fee upon early termination of this Agreement. If you are utilizing a Trial Version, the License granted under this Agreement will automatically terminate after seven days from the date that you first use the Software if the license is not earlier terminated by Licensor. After such termination, Licensor shall maintain any User Materials and data stored on the Software by you for a period not less than 30 days.
- 8. **Third Party Software.** The Software may contain third party software which requires notices and/or additional terms and conditions. Such required third party software notices and/or additional terms and conditions and are made a part of and incorporated by reference into this Agreement. By accepting this Agreement, you are also accepting the additional terms and conditions, if any, set forth therein.
- 9. Governing Law. The laws of the State of Florida shall govern the construction of this Agreement and you agree to be subject to exclusive jurisdiction and venue of the state courts sitting in Sarasota County, Florida or the federal courts in Sarasota, Florida to resolve any disputes arising under this Agreement. In each case this Agreement shall be construed and enforced without regard to the United Nations Convention on the International Sale of Goods.
- 10. Your Representations and Warranties. You represent and warrant that in connection with your use of the Software, you shall supply truthful and accurate information to Licensor and shall comply with all applicable laws.
