- Opportunity to enhance powder museum area incorporating Maxfields Bridge.

Spoke to Council regarding previous correspondence regarding the widening of Foster Street however would like Council to reconsider previous suggested improvements to Foster Street Sale.

Budget Item 6 – Funding various projects in Loch Sport Kaye Hogben, Community Representative Group

Spoke to Council regarding the following matters:

- Disappointment with lack of reference to Loch Sport within the budget documentation.
- Loch Sport Community Plan (draft document), developing a shared pathway for Loch Sport which identified a need linking areas along National Park Road.
- Current walkway strategy plan still identifies National Park Road as only a medium priority.
- Many of the existing pathways are overgrown and in need of repair.

Trish Garnham, Loch Sport Committee Member (CRG) Spoke to Council regarding the following matters:

- Lions Park BBQ area and playground area rebuild (no mention in the budget)
- Safety for pedestrians to escape traffic when walking along Victoria Street & Marina Drive.

- Removal of bins from public areas around Marina, boat launching ramps.
- Provisions of doggy bags within the Loch Sport area
- Potential of sewer systems becoming blocked due to illegal dumping of rubbish into system

Budget Item 7 – Dargo Hall & Recreation Reserve Committee of Management Helen Hall, Secretary of Dargo Hall Committee Spoke to Council regarding the following matters:

- Mowing and slashing of public areas like hall, oval, tennis courts have been undertaken by the community (volunteer labour).
- Aging community impacting on continuation and request assistance from Council with undertaking some of the slashing for these reserves / clubs and in particular the swimming hole reserve area.

Budget Item 10 – Flooding Creek Foot Bridge Reinstatement Project Chris Morrison, Flood Creek Committee member Spoke to Council regarding the following matters:

- Previous footbridge replaced 10 years ago after flooding of area
- Bridge has since been replaced providing a linkage from the Western side of Sale onto the college playing fields.
- Various usage groups access the footbridge to use the grounds and we are seeking contribution from Council to complete upgrades by end of 2016
