# GAUSSIN strengthens its position in Canada as its ATM® and APM® are approved as eligible for subsidies for the purchase and rental of clean vehicles

ATM® and APM® will benefit from subsidies of up to 100,000 Canadian dollars (approximately 73,000 US\$) per vehicle from the Ministry of Transportation of Canada at the federal level, and 85,000\$ per ATM® (62,000 US\$) or 105,000\$ per APM® (77,000 US\$) from the Ministry of Transportation of Quebec

GAUSSIN (ALGAU - FR0013495298), a pioneer of clean and smart freight transport, announces that its ATM® and APM® vehicles, designed for logistics and port activities respectively, have been approved by the Ministry of Transportation of Canada and the Ministry of Transportation of Quebec. The purchase and lease of these vehicles, recognized as vehicles that contribute to the decarbonization of the transportation sector, will be encouraged by the granting of subsidies of up to \$100,000 (around US\$73,000) at the federal level. In Quebec, the subsidy amounts to \$105,000 (US\$77,000) for the APM® and \$85,000 (US\$62,000) for the ATM®. These federal and provincial grants can be combined for clients based in Quebec.

## GAUSSIN selected as a relevant player in carbon-free mobility

The Ministry of Transportation of Canada (Transport Canada) has established a program named Incentives for Medium- Heavy-duty Zero-Emission Vehicles (iMHZEV) for companies and organizations wishing to lease or purchase a new zero-emission medium and heavy duty vehicle. This program provides public grants for the purchase or lease of eligible vehicles.

The Quebec government also wants to promote the decarbonization of the province's transportation sector, as road transportation accounted for more than 35% of total greenhouse gas emissions in Quebec in 2018.

The ATM® 38T (logistics tractor) and the APM® 75T (port tractor) have been approved as vehicles eligible for subsidies by the Canadian authorities, both at the federal and Quebec levels. This approval is a new international recognition of GAUSSIN's zero emission technology.

### A measure favorable to GAUSSIN's development in North America

The incentives offered by the Canadian authorities will encourage and accelerate the conversion to low-carbon mobility for companies in the region.

For GAUSSIN's ATM® and APM®, Transport Canada is proposing a financial incentive of \$25,000 (approximately US\$18,000) per vehicle for a 12-month lease, \$50,000 (US\$36,500) for a 24-month lease or \$100,000 (US\$73,000) for a 48-month lease or the purchase of the vehicle. The Quebec Ministry of Transport offers a subsidy of \$85,000 (US\$62,000) per ATM® and \$105,000 (US\$77,000) per APM® for the purchase or lease of these vehicles for at least 4 years. A company based in Quebec can benefit from both the federal subsidy and the one offered by the Quebec authorities.

The approval of ATM® and APM® thus represents for GAUSSIN, beyond a new recognition of the quality of its technology, an opportunity to further increase its presence in North America, in a very buoyant context for the Group in the USA.

"I am pleased that our ATM logistics tractors and APM port tractors have been recognized in Canada as clean vehicles benefiting from public authority incentives. Our vehicles, which already have an excellent TCO (Total Cost of Ownership), become with this approval and these incentives a vector for accelerating the transition towards zero emission for port and logistics actors. For us, this recognition will encourage our commercial development in Canada, while GAUSSIN is already more established than ever in North America," said Christophe Gaussin, CEO of GAUSSIN.
