2020-2021 DISTRIBUTION STRATEGIES:

The Child Abuse Prevention Council (CAPC) began public awareness email campaigns during FY 20-21 in an effort to conduct outreach digitally and virtually connect with a large audience. Topics thus far have included: financial literacy, safe surrender laws, child abuse reporting and mental health (specifically managing anxiety). These campaigns include informational flyers, presentations and trainings, social media posts, topical articles in quarterly newsletters and additional resources to assist community members.



Trainings and Accreditations

Through a collaborative relationship with the Chicago School of Professional Psychology, ACEs Aware Initiative and CAPC members, CAPC hosted 14 workshops with Continuing Education Units (CEUs) attached on topics such as Adverse Childhood Experiences (ACEs), vicarious trauma, mandated reporting, trauma-informed care and resiliency. Due to the virtual formatting and hosting of these workshops, CAPC was able to reach over 4,000 attendees, averaging over 200 attendees per session. These workshops were generally well received and have become a staple for family-serving professionals to receive monthly, accessible training opportunities.



2020 ANNUAL ADOPT-A-FAMILY PROJECT:

The 2020 Annual Adopt-A-Family Project was conducted in collaboration with Junior League of Orange County and provided community-based support to at-risk parents and families during the 2020 holiday season. Families and children from the Tustin, Manzanita Park and Downtown Family Resource Centers were nominated by Family Support Advocates throughout November 2020 and CAPC provided the link, supportive supplies and delivery of secured donations by Junior League of Orange County and other supporters. Gifts, including clothes, books, educational toys and games, as well as many basic needs items, were distributed to families at Family Resource Centers in December 2020.

Child Abuse Awareness Month

BLUE RIBBON WEEK

COVID-19 paused plans to bring Blue Ribbon Week to local schools, a goal from the 2020 Blue Ribbon Month campaign. But thanks to close collaboration with proactive high school student Taylor B., Capistrano Valley High School conducted their very own Blue Ribbon Week and created a Blue Ribbon club to galvanize youth leaders at the school to focus on prevention in their communities. Other highlights included a social media campaign and online videos created by the Blue Ribbon club and great participation in the 2021 Blue Ribbon Youth Art Contest. A Blue Ribbon Week also took place at Latino Health Access and Palm Lane Elementary (a private school).

BLUE RIBBON MONTH

Public awareness increased as a result of the promotion and coordination of Blue Ribbon Month activities with the all new additions of a community forum with a panel of experts, a second Family Fun Day and a candlelight vigil hosted by CAPC, and numerous first-ever Blue Ribbon efforts planned and hosted by organizations represented on the Blue Ribbon Committee. Participant and community awareness kits were distributed both in-person at food distributions and digitally through e-blasts, social media and digital downloads.

A digital presentation, consisting of live and prerecorded elements, kicked off the 2021 Child Abuse Awareness Month Campaign. This year's theme was "Speak Up...Save a Child," focusing on mandated and community reporting. The event was emceed by Vikki Vargas from NBC4 News and introduced by CAPC Member Katherine Hamel. Additional program elements include: a member of the Orange County Board of Supervisors presenting a resolution recognizing CAPC efforts to lead an annual Blue Ribbon Month campaign, updates from County of Orange Social Services Agency, perspective from Orange County District Attorney Todd Spitzer, testimonials from Olympian Carlin Isles and Resource Parent Vanessa Acosta, a mini-presentation on ACEs and toxic stress with Dr. Eric Ball, recognition of the 2021 awardees and a moment of remembrance for those affected by child abuse and neglect over the last year.



The 2021 Blue Ribbon Kickoff Ceremony amassed more than 600 views in a week with 393 viewers tuning in live through a variety of a platforms. The feedback has been very positive and the recording of the event allows for further reach than any physical kickoff event convened in the past. The kickoff video will be permanently housed on YouTube, Facebook and The Raise Foundation/CAPC website.
