All payments are due by March 15th with the exception of Cart Storage which is due on February 28th.

All Seasonal Memberships expire on October 31st of the calendar year.

All Members must pay a \$1.00 registration fee each day of golf.

Family memberships consist of couple with same address and unmarried children up to 21 years old.

Children under 14 are allowed on the golf course on weekends and holidays only when accompanied by an adult.

Children under 18 are not allowed to play on Thursdays after 11:00 a.m.
