

Digital Czech Republic in 2022

Dear guests,

I am honored to welcome you to our VII. year of the international conference: Digital Czech Republic.

Digitization has given the Czech Republic the opportunity to become one of the most developed countries in the world. The conference, which is traditionally organized every year by the Institute for Politics and Society, serves as a source to achieve this goal. We provide a platform for key figures such as politicians, academics, members of the private and public sectors, and government officials from within the Czech Republic and abroad. Quality of life has improved in the Czech Republic due to the vital conversations on digitization that have taken place at this conference over the years.

I would like to begin by taking note of the complexity of this period of time. As soon as Europe began to shake off the consequences caused by the COVID-19 pandemic, our lives were again drastically affected by the war in Ukraine. For obvious reasons, unprecedented Russian aggression is drawing attention to issues other than digitization. Nevertheless, it would be a mistake to neglect digitization even in these difficult times. The war in Ukraine shows, among other things, how crucial it is to have a secure cyberspace, the ability to process information, know how to refute misinformation, and to be proficient with communication platforms. As with any other crisis, this one can also be an opportunity, and this is especially valid in the area of digitization. For instance, attacks by Russian hackers can be an obstacle to effective eGovernment, which is one of the topics we will address during the conference.

INTRODUCTION

The COVID-19 pandemic and the war in Ukraine have both fully exposed the dangerous potential of creating and spreading disinformation. Many of the same individuals that used to spread so much misinformation about COVID-19 have now shifted their focus to lying about Ukraine. The influence of obscure alternative news sites and information is increasing, as it is easier and faster to spread due to social networks. The debate is also intensifying over whether or not to limit this information, and if so, to what extent. This also begs the question of who should do so, and according to what rules? The major question is whether space should be left for the spread of deliberately created lies and provocations, as they aim to deceive the target society, in our case the Czech Republic.

Bitcoin trading is constantly becoming more topical. What seemed to be up until recently science fiction, is a reality today. A significant part of the society, which was not previously interested in virtual currencies, nowadays trades with them and watches how their value is constantly increasing or decreasing. If there exists something that poses an extraordinary risk and at the same time an unprecedented opportunity, it is only the virtual currencies. For the future, there are massive plans for them, and it will be interesting to discover to what extent they will affect our lives.

Digital Czech Republic will provide a platform for sharing ideas and innovations, as well as personal experiences of individual participants. I am glad that after nearly two years of the pandemic, we can attend the conference physically again. I believe that we will be able to build on previously successful years, and the conference will be a pleasant experience for you.

On behalf of the Institute for Politics and Society, I hope you will enjoy the conference and I look forward to all the stimulating and interesting discussions.

The Czech Republic on the Way From the Assembly Plant to the Brain Room

The digital transformation of the economy represents an opportunity to move the Czech Republic among the most developed countries in the world. However, its successful achievement is conditional not only on close and intensive cooperation between the public and private sectors, but also on significant investment in research, development and innovation.

The Czech Republic has a long-term vision, The Country For the Future, which aims to open up the country to innovative ideas and unleash the full potential of robotics, automation and other trends based on Industry 4.0. This strategy presents a roadmap for transforming the domestic economy from an assembly plant based on cheap labor to a think tank creating high value-added products and services.

The global Coronavirus pandemic has fully exposed the weaknesses of the Czech economy. In addition, the working environment is also being transformed. Home office has gone from a welcome benefit to a practically normal standard in professions that allow it. At the same time, questions have arisen as to what the offices of the future should look like or how to ensure suitable working conditions for working from home. We could find many similar examples.

What is the state of Czech science and research? What are the obstacles to faster development of the digital economy? Can the Czech economy afford to automate its production capacities more significantly? What has the Coronavirus pandemic revealed? Will working from home become a fixed part of our working life? In what direction is the working environment changing? And will we see a four-day work week?

Progress and New Challenges of eGovernment

Digitization of public administration has long been one of the government's top priorities. It is no exaggeration to say that 2022 is the year of eGovernment and significant changes. In practice, for example, the Act on the Right to Digital Services or the Law nicknamed DEPO, which amends over 160 pieces of legislation in connection with the further computerization of the procedures of public authorities, will come into operation. The package of changes deepens the computerization of public administration in the Czech Republic.

The Act on the Right to Digital Services includes, for example, the introduction of mandatory receipt of postal data messages by legal and entrepreneurial natural persons or provides for the possibility of driving a car without the need to carry a physical driving licence. Gradually, other digital rights from the so-called digital constitution will also come into force. Examples include the legalisation of an electronic signature, the right to use data or the right to certify a digital act.

It seems that in the coming years we could also see the end of identification by means of a personal identification number. It is to be replaced by the concept of electronic identification based on the principle of decentralized identity without an intermediary in the form of the so-called national point (NIA). In addition, in 2023, a provision will come into effect that obliges every entrepreneurial legal and natural person to set up a data box.

Is the Czech Republic finally really "digital"? Will we see a situation where, following the example of Estonia, we will have to physically go to the office only in exceptional cases? What other news awaits us this year? And will the Citizen's Portal become a real center of communication between the state and the citizens?

Internet, Artificial Intelligence, Bitcoin... and What Comes Next?

The Internet is undoubtedly one of the most important inventions in the history of mankind and has a significant influence on the shape of the contemporary world. For many, therefore, it is an inseparable part of our lives. We use it for work, education and communication. But it is also a place where we spend our free time or look for fun. In connection with the internet, however, there is increasing talk about the use of user data.

So-called big data has not only a positive, but also its dark side. Companies are collecting more and more information about us. In particular, this concerns data about what we do on the Internet and how we behave. They obtain data from social networks, website visits, login logs or from our activity on phones. They then use the data to analyse behaviour and anticipate needs, which allows them to improve the personalisation of messages and, in turn, influence the behaviour of civil society.

However, the potential of big data is much broader than it may seem at first glance. Their use can be beneficial in solving problems occurring, for example, in medicine, unemployment, crime or security. In addition, they are also used by companies in combination with artificial intelligence algorithms to automate processes that save time and resources, and ultimately lead to greater economic competitiveness.

Is our data modern gold? Have we fully exploited the potential of big data? What is the future of artificial intelligence? Can Czech companies work with data? Is there a need for better regulation of data collection?

Financial Technology of the Future

Not long ago sci-fi, today reality. Few sectors are developing as dynamically as financial services. Who among us, for example, could have imagined just a few years ago that we would pay for our purchases using a watch or a mobile phone, all secured with biometric data?

FinTech is becoming increasingly popular due to its simplicity and high level of security, and it is no wonder that it covers an increasingly diverse range of services. They make them available to us 24 hours a day, 7 days a week and 365 days a year. In addition, we are not tied to a place, and thanks to security features such as artificial intelligence, biometric data or algorithms that warn of suspicious behavior, we can use them from virtually anywhere in the world without their misuse.

Digital technologies are also becoming an inspiration in building eGovernment. An example is the Banking Identity project, through which citizens can communicate electronically with the authorities and use various services simply thanks to identification by logging into their internet banking. But FinTech also brings obstacles. For example, cashless payments are very popular with Czechs, which to some extent causes us to become dependent on payment companies.

Will we see the introduction of a digital currency? Can the identity of citizens be stolen? And what new technologies have a perspective from the point of view of the state?

Smart eMobility for the 21st Century

Not only fast and reliable, but also smart, environmentally friendly, affordable or multimodal. This is only a fraction of the attributes that are increasingly associated with modern transport of the 21st century. In short, transport is increasingly demanded from all directions.

The European Union has set itself an ambitious target of reducing greenhouse gas emissions by 60% in 2050 compared to 1990 levels. In this context, the Czech Republic faces a number of challenges. It wants to achieve this goal by promoting electromobility, shifting freight transport from roads to railways and waterways, building a motorway and high-speed rail network.

Digitalisation is one of the tools to achieve this. From the digitization agenda, the Ministry of Transport has already managed to introduce projects such as a single ticket, an electronic vignette, a new electronic toll system, the status of the point account on the Citizen's Portal, the mileage online, a digitized photo when applying for a driver's license, a drone register or registration for tests of safety advisors for the transport of dangerous substances and other things.

What other digital projects in the field of transport is the state preparing? Is the Czech Republic ready for electromobility? Will we see a more pronounced use of hydrogen propulsion? When will the motorway network and high-speed rail be fully completed? And when will we finally see real "smart cities"?

The numbers speak clearly, the Czech Republic is one of the great powers in the field of eCommerce. For example, in per capita terms, we boast one of the highest number of e-shops in Europe. In addition, the number is growing year by year, as well as the turnover of the entire segment. Continuous improvement in these areas is a permanent challenge for every company. And in the Coronavirus era, this was amplified. It's neither news nor a surprise that Covid's actions have ultimately driven eCommerce to faster growth and record results.

Where is Czech eCommerce going and what is it building towards? What changes can we expect in the coming years? What are the challenges it faces and, conversely, what are its biggest advantages? How does the Czech Republic compare to other European countries? What hinders young entrepreneurs from developing their projects? How can the EU support the development of startups?

Democracy and the Digital Society 2.0

Liberal democracy has not had the best of years in recent years. Governments around the world are facing hybrid attacks and populists. The influence of so-called alternative news sites and information is growing, which is spread more easily than ever before thanks to various social networks. Residents are more likely to face misinformation, conspiracy theories or manipulative techniques. Thus, to distinguish reality from untruth becomes increasingly difficult. With a certain degree of exaggeration, we can say that democratic principles are shaking to their very foundations as a result of hybrid attacks, and the increasingly frequent demonstrations not only throughout Europe, but also in the United States, for example, are clear proof of this.

It is absolutely clear that the European Union must actively address these current challenges and establish rules that eliminate hybrid threats. The European Plan for the Defence of Democracy is in charge of the Czech EU Commissioner Věra Jourová. In the fight against threats in cyberspace, it should help in addition to the so-called "cyber threats". The Digital Services Act also includes the long-awaited Democracy Action Plan. Although this document is not legally binding in itself, it outlines the direction that the European Union should take in the coming months in the area of protecting democratic principles and processes.

How are societies and democratic processes changing under the influence of social networks? How should the originators of disinformation be dealt with, whether they are state or non-state actors? And what will the relationship between public institutions and Internet giants, who often pursue different interests, look like in the future?

Digital Security in the Age of Cyber Wars

Internet, cloud solutions, 5G, video conferencing, artificial intelligence, social networks or virtual environments. A brief list of technologies that are playing an increasingly important role in our lives. The digitization of society and the economy has increased drastically during the coronavirus pandemic, and IT solutions are now an absolute prerequisite for keeping a variety of activities running.

The dependence on technology has never been greater, and cyber attackers are aware of this. The rapid development of digital products and services faces new security challenges that need to be uncovered and addressed around the world. Hacking attacks are becoming increasingly sophisticated, and there is a shift from targeted attacks to new forms of massive threats to millions of businesses and citizens.

If we want to successfully respond to today's security challenges, we cannot do without cooperation at international level. Through the European Union Agency for Cybersecurity (ENISA), the EU takes action to address cybersecurity challenges, promotes cyber diplomacy, strengthens cyber defence, supports research and innovation, and protects critical infrastructure.

What impact has the coronavirus pandemic had on cybersecurity? What are the European Council conclusions on the EU Cybersecurity Strategy for the Digital Decade? Is it possible to achieve strategic autonomy regarding cybersecurity while maintaining an open economy? How does the Czech Republic compare to other Member States in this area?

The Digital Age of Education

Few areas have experienced such a "revolution" since the outbreak of the coronavirus pandemic as education. The pandemic has revealed a number of challenges to education and training systems related to institutions' digital capacities, teacher education, and overall levels of digital skills and competences.

The European Union has therefore renewed a policy initiative to promote a sustainable and effective adaptation of Member States' education and training systems to the digital age – the Digital Education Action Plan (2021-2027). It is a long-term strategic vision for high-quality, inclusive, and accessible European digital education.

The Digital Education Plan builds on the challenges and opportunities of the coronavirus pandemic and seeks closer cooperation between the European Union in the field of digital education. Promoting the digitalisation of teaching methods and pedagogy, together with providing the infrastructure needed for effective distance learning, aims to improve the quality and quantity of distance learning.

Which states have best adapted to forced changes in teaching and in what way? Conversely, which ones had a problem with distance learning? What is the potential of remote learning? How will the Digital Education Action Plan affect education in the Czech Republic? Will the digitization of the education system affect the students themselves? What is the future of education in the EU?

eHealth

The healthcare sector has been undergoing a fundamental transformation around the world in recent years and the health system is improving. The main benefits of digitising healthcare include improving prevention, diagnosis, treatment or monitoring of patients' healthcare and lifestyle. In addition, information is shared more effectively between physicians, medical procedures are shared, and communication is improved, which increases the overall quality of care.

In the Czech Republic, the Act on the Computerization of Healthcare was adopted in 2021, on the basis of which the eHealth Portal is to be established from 2023. Patients and doctors will find an offer of eHealth services along with a web and mobile application. Importantly, the law does not introduce any centralized repository of medical records or data on the patient's health, but allows the safe transfer of medical documentation or its parts between health service providers or between the provider and the health insurance company.

In connection with the coronavirus pandemic, the socalled telemedicine is also gaining in importance. This allows patients to consult their health with doctors online without having to leave their home, making the healthcare system much more efficient. Inspiration can be drawn from countries such as Denmark, Spain or the United Kingdom, which are setting trends in the field of eHealth.

What are the barriers to the development of digital health? What impact has the COVID-19 pandemic had on eHealth? What are the prospects for digital healthcare in the future in the Czech Republic? How can the European Union support the development of digital health? So what is hindering the development of eHealth and the expected financial savings in healthcare?

He has worked professionally in several Czech and multinational companies in the field of information technology, for example for Newton IT, Monster Worldwide, T-Mobile and started the Job Portal Air Jobs. He is married and has two children. He is fluent in English, French and Russian.



Timmy Dooley

Senator Timmy Dooley was appointed to the 26th Session of the Seanad in 2020 and is Fianna Fáil Seanadu's current spokesperson for climate, communications networks, and transport. He was Technical Director from 2007 to 2020 and served as Spokesperson for Transport, Tourism, and Sport until 2016 when he moved into climate action and communications. Timmy was also in Seanad from 2002 to 2007, when he was elected to the administrative body. Dubravka Šuica entered politics in the 1990s as a Member of the Croatian Democratic Union and served as a Member of the Croatian Parliament and Vice-Chair of the EU Integration Committee. Between 2004 and 2009 she was a Board Member of the Union of the Association of Towns and Municipalities of the Republic of Croatia. For ten years she was the Vice-President of Congress of Local and Regional Authorities of the Council of Europe. From 2013 to 2019 Dubravka Šuica served as a Member of the European Parliament and Vice-Chair of the Foreign Affairs Committee. In June 2019, Šuica was elected as the first Vice-Chair of EPP Group in the European Parliament. Since 2012, she has been the Vice-President of EPP Women.



Svetlana Tsikhanouskaya

Sviatlana Tsikhanouskaya is the leader of the Belarusian democratic forces, which, according to independent observers, defeated autocratic President Alexander Lukashenko in the August 9, presidential election. She entered the race after her husband was arrested for his presidential ambitions. Lukashenko publicly dismissed her as a "housewife" and declared that a woman could not become president. Tsikhanouskaya united the Belarusian democratic forces along with two other leaders - Maria Kalesnikova and Veronika Capkalova. After her forced exile, Tsikhanouskaya inspired unprecedented peaceful protests across Belarus, some of them numbering hundreds of thousands. She visited more than 20 countries, where she collected support for a free Belarus. In 2020, Lithuanian President Nauseda and Norwegian parliamentarians nominated her for the Nobel Peace Prize. She is ranked in the TOP 50 most influential personalities according to Bloomberg, the 12 most influential women according to the Financial Times and the 28 most influential Europeans according to POLITICO.
