APPROVAL OF MARCH 24, 2023 MEETING MINUTES

Chairman O'Brien asked for a motion to approve the March 24, 2023 meeting minutes.

Motion made by Mr. Nolette.

Seconded by Mr. Strough.

Hearing no additions or corrections and no opposed, motion carried.

ALL BRANDS REDEMPTION CENTER- JOSEPH BRAND

Ms. Gilles discussed the All Brands Redemption Center/Joe Brand foreclosure. The foreclosure sale date of the business property is August 14, 2023. RPB has a first and second position mortgage on the business property and the RDC has a third position. Both entities also have a second position behind a private mortgage on the Brand residence, but neither entity has initiated foreclosure on the residence to date. All Brands Redemption Center/Joe Brand has two loans with the RPB. The first loan has a combined principal, interest, and late fees due totaling \$13,013.52. Loan two is a consolidation of two previous loans with principal, interest, and late fees due totaling \$189,316.21. Combined with legal fees and back taxes paid by the RPB, total owed is \$229,810.37. Ms. Gilles noted that loan three is with the RDC and total owed is \$51,911.48. According to Warren County tax records, full market value of the business property is \$210,300. Ms. Gilles also stated that the business property is currently listed for sale by Mr. Brand. Ms. Gilles asked the committee to set a maximum bid for the property in the foreclosure sale. Ms. Gilles noted after the foreclosure sale of All Brand Redemption Center/Joe Brand concludes, All Brands Redemption Center will not be released from its liabilities as the RPB still has additional collateral rights. A lengthy discussion ensued on the maximum bid amount, with suggestions ranging from \$50,000 to \$200,000.

Chairman O'Brien asked for a motion to set the maximum bid amount for the property at the foreclosure sale at \$150,000.

Motion by Mr. Strough. No second. Item failed.

With no further discussion, Chairman O'Brien entertained a motion to set the maximum bid amount for the property at the foreclosure sale at \$100,000.

Motion by Mr. Strough.
Seconded by Mr. Nolette.
Hearing no other discussion and no opposed, motion carried.
