# **Move Out & Cleaning Instructions**

United Realty strives to provide tenants with products which reflect its standards. For this reason, Residents subleasing their unit must clean the Property upon move-out according to the instructions below. In addition, Residents must report any damages so necessary repairs can be made for the new tenants.

Please leave the property in the manner received, or better. Leave the property how you would expect it to be if you were moving in.

### Kitchen, Dining Area, & Utility Room

- Clean refrigerator inside and out, turn it off, unscrew the bulb (CAUTION HOT!), and leave the door open.
- Clean the stove, oven, top, drip pans, control panel and underneath the top thoroughly.
- Clean the dishwasher. (Run the dishwasher through a cycle with a cup of vinegar sitting on top shelf.)
- Clean the countertop, vent hood, and sink.
- Clean washer and dryer inside and out (if provided).
- Wipe down all the cabinets and drawers, inside and out.
- Vacuum or sweep and mop floor.
- Wipe off light fixtures and/or ceiling fan and replace any burned out light bulbs.
- Dust any blinds and windowsills.

# Living Room & Bedroom

- Wipe fingerprints and other marks from switches, walls, and doors.
- Vacuum or sweep and mop floor and clean all baseboards.
- Wipe off light fixtures and/or ceiling fan and replace any burned out light bulbs.
- Dust any blinds and windowsills.
- Remove all items from closets and wipe closet shelves.

# Bathroom

- Clean tub, toilet, vanity, and surrounding area.
- Clean mirrors and tile.
- Clean sink and all plumbing fixtures.

- Wipe down all the cabinets and drawers, inside and out.
- Vacuum or sweep and mop floor and clean all baseboards.
- Wipe off light fixtures and/or ceiling fan and replace any burned out light bulbs.
- Dust any blinds and windowsills.

#### Yard/outside the unit

- Remove all trash in yard and outside the unit.
- Sweep off all porches, patios, and balconies.
- Any loose trash must be in a bag and put to the curb or trash pickup area.
- Trash container must be put to the curb where garbage pickup services will pick up.
- Fill in all holes from pet (if applicable).
- Remove any pet feces.

## Misc.

- A/C return grill must be clean and must have a clean air filter.
- Test and replace dead batteries in smoke detectors.

#### <u>Keys</u>

- Return all door keys, remote garage door openers, and security access cards.
- If a mailbox key was provided by United Realty the unit must be turned in to our office.
- If you picked up your mailbox key from the post office, then it must be returned to the post office.
- Provide our office with a forwarding address.
