

## Who Are We?

The New York State Council of Churches (NYSCOC) is a statewide organization through which Protestant Christians work together to accomplish mission goals which focus on Advocacy, Chaplaincy, Education and Worship, and Ecumenicism. Founded in the late 19th century, The Council represents 7,500 protestant denominations throughout New York state. The Council comprises 9 partner denominations, which are detailed on our Member Denominations page. Each denomination sends representation to our Executive Committee and provides financial support. Other denominations which are members of the National Council of Churches may also have representation to the Council.

The council aims to promote Christian and Interfaith unity, advocate for social justice and peace, and address issues of common concern. It provides an avenue for congregations to live out Jesus' call to be God's face and hands in today's world. Christian involvement in social witness and public policy is a response to God's call to do justice, love kindness, and walk humbly with god. The Council's priority Advocacy areas are:

- Racial/Immigration Justice
- Environmental/Climate Justice
- Voting Justice
- Healthcare Justice

- Provide training and tools for community organizing and legislative actions for faith-based organizations.
- Working through the Interfaith Affordable Housing Collaborative and Partnership for Affordable Housing NYSCOC helps faith communities analyze their property and figure out how to use it for affordable housing & other uses consistent with their mission. - The New York State Council of Churches certifies and supports chaplains in state
  institutions including the Department of Corrections and Community Supervision, Office
  of Children and Family Services, and Office of Mental Health. We sponsor an annual
  conference for chaplains and provide other continuing education opportunities.

- Foster ecumenical and interfaith collaboration and relationships-including with the world, national, and local councils of churches. Advocacy for human rights and religious freedom in India and Palestine/Israel and Afghanistan
- Provide educational and worship resources used in faith formation for youth and adults-We gather, analyze, and publicize information which helps people of all ages live out their faith in the public square
