A reminder that the New York State Council of Churches has strongly endorsed the proposal of the farm wage board to require overtime pay for increasing numbers of qualifying hours over a ten year period for farm workers. By year ten, any hours worked over 40 would qualify for overtime. In addition, the Governor has thoughtfully offered a corresponding tax credit to employers to cover their gradual increase in overtime costs.

Unfortunately, Congressman Antonio Delgado is pressuring the Governor to back off her overtime proposal. We just heard from our partners, Rural and Migrant Ministry about this situation and we need you to call Congressman Delgado and tell him to back off! NO ROLBACKS ON BAIL, RAISE THE AGE AND DISCOVERY

New York State Council of Churches strongly opposes any proposed rollbacks to our bail reform, raise the age and discovery laws. If there is any debate about rollbacks it needs to be done after the budget is done so we can have a complete and transparent conversation about what the laws actually do and do not do and to discuss better solutions than rollbacks to address crime, gun violence and public safety.
