The Family Business Council Gulf (FBCG) is a private, not-for-profit membership organization registered in the DIFC pursuant to License No. OL 1270 with an office address at Unit 17-0, Level 3, Gate Village Building 4, Dubai International Financial Centre, PO Box 214432, Dubai, United Arab Emirates (hereinafter "FBCG"). These are the terms and conditions upon which each nomination and/or entry shall be subject. By participating in this Award initiative by way of nominating and/or nomination and/or entry, the Applicant ('You") agree to accept these terms and conditions and any amendments to these terms and conditions. FBCG reserves the right to amend these terms and conditions at any time and such changes shall be deemed to be notified to you by their publication online.

Awards Rules & Regulations

General Regulations

Entries

- 1. Applicant must be over the age of 18.
- 2. The Awards are open to any individual or organization so long as they meet the minimum nomination and/or entry criteria per category.
- 3. Nomination and/or entry is free.
- 4. An Applicant may submit more than one nomination and/or entry per category.
- 5. Entries must be made in English or Arabic using the Nomination and/or entry Forms.
- 6. FBCG reserves the following rights:
 - a. refuse to disclose to an individual personal information that is evaluative, or opinion material compiled solely for the purpose of determining the individual's suitability for receipt of the award
 - b. to verify the accuracy of the information provided in the nomination or nomination and/or entry form



- c. to withhold an award in any year in which there is no candidate who meets the selection criteria
- d. to cancel entries not received in full by the deadline
- 7. Nominees will only be considered for awards for which they have submitted full and complete submissions and expressed in writing commitment to the process. Applicants and/or nominees may be requested to provide additional information during the process.
- 8. Shortlists and finalists selected solely on the information provided in the nomination and/or entry form. An Applicant should ensure sufficient information about the business or individual, including how they meet the main criteria for the category they've been nominated, to enable fair assessment.
- 9. All materials submitted must:
 - a. Describe original work; and
 - b. Not contain fabricated or false information
- 10. Each Applicant is responsible to ensure that, by applying to the awards, they are not infringing any copyright laws, privacy clause or intellectual property of a third party.
- 11. No deferrals of awards will be allowed. All Applicants must make themselves available to receive the award at the FBCG Annual Summit of the year of the application. Failure to be available will be considered a withdrawal of the application, unless under special circumstances.
- 12. Winning entries may be featured in case studies. All applicable permissions must be obtained by Applicants for all materials submitted as part of the Award submission for which they are not the exclusive owner. It will be the responsibility of the Applicant to clear all necessary permissions, including client approval where necessary, before submitting an nomination and/or entry.
- 13. FBCG is not obliged to provide feedback on individual entries that have either not made the shortlist or won an award.
- 14. Receipt of awards is conditional upon the recipient's compliance with all the terms, conditions, guidelines, and regulations as set out in the terms of reference.

Selection Process

- 1. All nominations are judged against criteria set out in the Categories.
- 2. All nominations will be reviewed and shortlisted by FBCG management, with this decision being made by FBCG's sole and absolute discretion.
- 3. An independent Jury is formed by FBCG management in conjunction with FBCG leadership. Jury is generally composed of FBCG Board, FBCG NxG members, academics, and family business experts. Jury is led and coordinated by FBCG management.
- 4. The Jury will score each of the entries on the shortlist and the finalists against a predetermined set of criteria.
- 5. A Jury Chairperson is appointed to coordinates and moderates the decision of the Jury. Should no decision be reached among Jury members, the Jury Chairperson will have casting vote.
- 6. The Jury are requested to declare an interest and remove themselves form the process if they are asked to judge an nomination and/or entry that poses a conflict of interest.
- 7. The decision of the Jury is final.



Confidentiality

- 1. FBCG respects as confidential any financial data submitted unless given express permission to use it. If there is a particular part of the nomination and/or entry that cannot be used, please clarify this on the nomination and/or entry.
- 2. By entering the FBCG Family Business Awards, individuals or businesses authorize FBCG and the Jury to use the data and certain visual materials submitted, for the purpose of the awards.

Responsibilities of Applicants, Finalists, and the Award Winner:

- 1. Participants agree to complete a survey at the close of the competition designed to determine satisfaction levels and identify areas for improvement.
- 2. The finalists agree to participate in the pitch day with the Jury.
- 3. The winners must attend to FBCG Annual Summit and participate in the award ceremony. All winners will be granted one complimentary ticket to the Summit and gala dinner; and if deemed necessary a return economy flight and overnight stay in 4* hotel in Dubai, UAE.
