## GENERAL MANAGEMENT COMMITMENTS

- Comply to the legal requirements established both in the legal regulations in force and in the regulations that develop them, and to the criteria or specifications indicated in the ISO 45001 and ISO 14001 standards, and in the different management systems of our clients.
- Be an open company, that has collaboration with its "partners" and other parties involved in the different projects, such as clients, suppliers, and public bodies or social agents
- The satisfaction of Exus employees, so that they are motivated, giving the necessary confidence to achieve the guidelines and objectives set by the company. With this, Exus intends to develop a corporate culture that encourages consultation and participation of employees, in an environment of tolerance, transparency and flexibility, regarding an open exchange of ideas and opinions at all levels.

- Control and manage emergency plans and measures at the centres that Exus has under management for both, employees present at the facility and other parties involved.
- Control and monitoring of the adequate status, and continuous improvement of the facilities, which guarantees minimum conditions of health and safety of the employees during the development of their activities.
- Identification, control, and continuous management, to reduce workplace accidents and health and safety incidents that may arise in the different work centres that Exus has under its management.

## **ENVIRONMENTAL PRINCIPLES**

- Prevention of pollution and protection of the environment in the efficient management of energy resources, to optimize energy consumption, natural resources, and protection of biodiversity.
- Responsible management and evaluation of the repercussion or impact that our services have on the environment, to prevent, eliminate or, failing that, compensate for its possible consequences.
