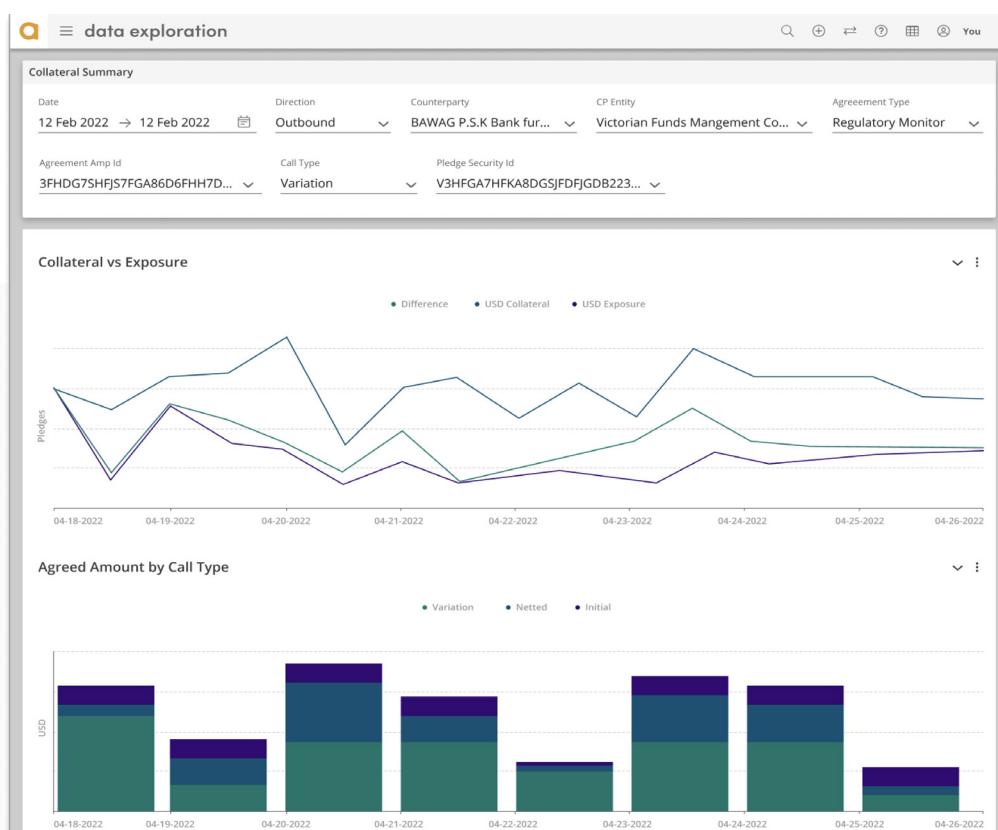

- Party Performance – A variety of business performance statistics by your and your counterparties' perspectives
- Risk – IM Exposure Manager breakdowns and trends, including the IM industry comparative report
- Collateral Summary – Pledged collateral trends and breakdowns
- Dispute Monitor – Dispute rates, ages, values, and trends by counterparties and agreements
 - Cumulative – Tracks number of consecutive disputes per agreement without reference to direction
 - Directional – Tracks number of consecutive disputes per agreements based on trading party direction
