In order to make serving a safe and enjoyable experience, there are a few things all of our team members agree to. Please read these carefully and check the statement acknowledging you agree to these standards.

I GIVE PERMISSION FOR MY PICTURE TO BE TAKEN

I grant to Velocity Church the right to make photo, video, and audio recordings of me as well as the perpetual, world-wide right to record, re-record, copy, edit, reproduce, publicly display, perform and distribute the recordings in any way consistent with Velocity Church's ministry, including use on the Internet. I waive the right to inspect or approve the finished product wherein the recording appears.

I WON'T SHARE CONFIDENTIAL INFORMATION

Velocity Church wishes to maintain in confidence all information including marketing information, data, technology, commercial and research strategies, trade secrets, inventions and know-how disclosed by Velocity Church to me, directly or indirectly, in written, oral or other tangible forms. Velocity Church also wishes to keep all contact information private and prohibits it to be used for personal reasons. In this regard, I agree that I will not disclose the confidential information with others without prior written consent of Velocity Church, both during or after my volunteer service.

I UNDERSTAND THAT THIS IS A VOLUNTEER ROLE

I acknowledge that I am volunteering my time and efforts in service for Christ through the ministries of Velocity Church, and that I will receive no monetary compensation or insurance benefits for my time or services performed. Furthermore, I acknowledge and accept the risk of physical injury that could occur from my participation as a volunteer. Except for gross negligence on the part of Velocity Church, I accept personal responsibility for any bodily or personal injury sustained while I am volunteering. I release and agree to indemnify and hold harmless Velocity Church, and its officers, directors, and representatives from any liability, injury, damage, loss, accidents, delay or irregularity related to being a volunteer for Velocity Church.

I UNDERSTAND THAT WHAT I CREATE AT CHURCH BELONGS TO THE CHURCH
