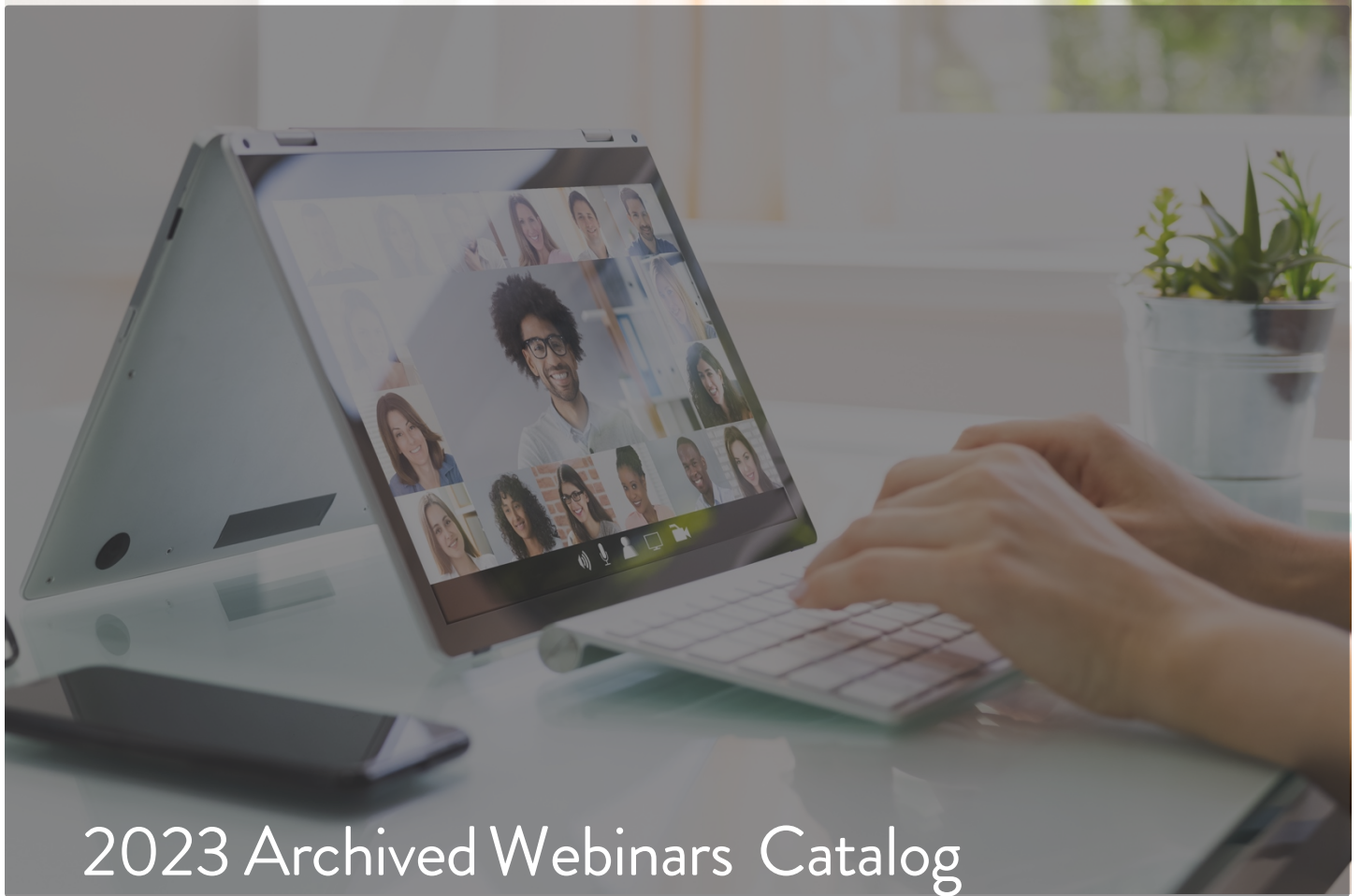

Effective Nonprofit Governance: Board Roles and Responsibilities - Governance Series

Boards have two fundamental obligations: To protect the assets of the organization (tangible and intangible) and ensure organizational sustainability (stewardship), and to ensure all activities are aligned with the mission and core values of the organization.

This session will delineate and clarify the legal duties, roles, and responsibilities of the board and of individual board members and explore ways to translate those responsibilities into meaningful actions.

Building BRIDGES: Mentorship and Advocacy for Justice-Involved Youth

Audience: CASA/GAL Local Program Staff and CASA/GAL State Organization Staff

Attendees of this webinar will receive an introduction to the CASA for Children of DC BRIDGES program, gain insight into the foster care-to-prison pipeline and the intersection of childhood trauma and juvenile justice, understand the risk and protective factors of juvenile justice involvement and the unique needs of juvenile justice youth and recognize how positive engagement can help justice-involved youth to reduce recidivism.

CASA for Children of DC has been a leading voice for DC's youth in foster care for 20 years, training over 2,200 volunteers to serve more than 2,000 youth impacted by abuse and neglect. Recognizing that the "Foster Care to Prison Pipeline" is a reality that too many youths face, CASA DC formed the BRIDGES program in 2019 to provide best interest advocacy to DC's justice-involved youth, including dual jacket youth involved in both the child welfare and justice systems.

The BRIDGES program in Washington, DC was a National CASA/GAL Promising Practices Spotlight Award winner in 2022 for its work with dual-jacket cases.

Creating a Gender Inclusive Environment in Child Welfare Systems

Audience: CASA/GAL Local Program Staff, CASA/GAL State Organization Staff and CASA/GAL Volunteers

There are between 1.5 to 2 times as many LGBTQ youth living in foster care as LGBTQ youth living outside of foster care. LGBTQ youth have a higher average number of foster care placements and are more likely to be living in a group home. Understanding the prevalence of children in the child welfare system who are LGBTQ youth and how to advocate for the needs of this population will be considered during the webinar. You will learn about transgender inclusion, including gender identity and expression, transgender, non-binary and gender-expansive identities and experiences; learn ways to create a gender-inclusive agency environment through policy and practice change; and explore language and behaviors that are welcoming and affirming to youth and adults with diverse gender identities and expressions.
