# McGlannan School Dress Code Guidelines

#### \*\*UNIFORMS TO BE PURCHASED THROUGH DENNIS UNIFORM\*\*

NO SWEATERS OR JACKETS OF OTHER SCHOOLS WILL BE ALLOWED!

## **GIRLS (All Grades)**

**SKORTS:** Any style in Plaid, Khaki, Pink or Blue Cord.

SHORTS: Bermuda style in Plaid, Solid Navy, Khaki, or Stone- with Dennis logo

**SLACKS:** Solid Navy, Khaki, or Stone – with Dennis logo. Dickie slacks OK.

NO leggings, spandex/lycra pants or "skinny pants".

**CAPRI:** Solid Navy, Khaki, Stone.

**SKIRTS:** Navy, or Khaki, or Plaid - with Dennis logo.

DICKIE SKIRTS ARE **NOT** PERMITTED.

NO SKIRT LENGTH SHORTER THAN 3" ABOVE THE KNEE.

**SHIRTS:** To be purchased through Dennis Uniform.

**100% Cotton** Any color knit polo with logo on left chest, long or short sleeve.

Advised The hem of the shirt must cover the midriff when arms are raised above the

head.

Required: 1 RED POLO knit for field trips.

**SOCKS:** Any color

Solid color tights OK for winter/NO LEGGINGS!

### **BOYS (All Grades)**

SHORTS: Navy, Khaki or Stone – with Dennis logo (no oversized permitted) – neatly

hemmed and worn at the waist. NO CARGO SHORTS.

**PANTS:** Navy, Khaki or Stone – with Dennis logo (no oversized permitted) – neatly

hemmed and worn at the waist. **NO CARGO PANTS.** 

SHIRTS: 100% Cotton

Advised

Any color knit polo with logo left chest – Dennis label (long or short sleeve)

Required: 1 RED POLO knit for field trips.

SOCKS: Any color

ALL STUDENTS NO JEANS (OF ANY COLOR), CARGO PANTS, CORDUROY

LEGGINGS or SWEATPANTS ARE PERMITTED

**SWEATER:** Navy, Forest, or White Cardigan – label: "School Apparel".

**SWEATSHIRT:** With hood or crewneck in Navy or Ash - NO LOGO – label "Hanes",

"M.J. SOFFIE" or "Lee".

**JACKET:** Navy or green polar fleece.

**BELT:** Plain solid color, no chains or large metal studs.

**SHOES:** Shoes must have closed toes and backs.

**GYM:** No uniform.

SWEATERS AND JACKETS OF OTHER SCHOOLS ARE NOT ALLOWED.

Blend and 100% Cotton are available in knit shirts, pants, shorts or slacks.

SWEATERS, JACKETS AND SWEATSHIRTS ARE TO BE SOLID IN COLOR WITH

NO GRAPHICS OR WRITING.

NAMES OF OTHER SCHOOLS ARE NOT ALLOWED

**General Grooming**: Inappropriate grooming and dress are distracting and decrease the learning environment. Following are guidelines for grooming and appearance.

- 1) All clothing must be of appropriate fit and size.
- 2) Hair is to be kept in a reasonable style, cut, and neatly combed.
- 3) No unnatural hair coloring.
- 4) Makeup is to be kept to a minimum and is permitted for upper division girls only.

  Acceptable makeup includes: pale pink or clear lipstick/gloss, and light blush.

  Not permitted: heavy eyeliner, eye shadow, mascara, and dark lipstick.
- 5) Caps and hats may **only be worn during P.E.** and must be removed before entering the classroom and prior to lunch.
- 6). **GIRLS**: **NOT PERMITTED**: Hoop earrings larger than one inch in diameter, dangling linear earrings longer than one inch, and chandelier earrings.

  Jewelry, as worn in a traditional manner, is acceptable.

**BOYS**: **NOT PERMITTED**: Piercings with jewelry.

Free Dress Days: On certain days throughout the school year and as a reward for compliance to the Dress Code, Administration provides "Free Dress" days. On these days students may attend school in non-uniform dress. However, because regular academic classes are held on these days it is imperative to maintain an appropriate learning environment. Therefore, while the majority of the regular Dress Code requirements do not apply, the following guidelines will remain:

- 1) Shorts, skorts, and skirts must be of Dress Code length.
- 2) Cut/torn clothing is not permitted.
- 3) Material must not be see-through.
- 4) Any cartoon, printing, or patterns on clothing must be in good taste, non-degrading and non-vulgar.
- 5) Midriff tops, tank tops, and spaghetti straps are not allowed.

The Administration of McGlannan School reserves the right to determine whether a student is groomed and dressed appropriately. Students who, at the sole discretion of the administration, do not meet the Dress Code requirements and guidelines will receive consequences ranging from a student warning, parent notification, to parents being asked to bring appropriate clothing to school so that the student may return to class. Repeat offenders may risk receiving more serious disciplinary consequences.
