LLC’S RESPONSE TO THE DIVISION OF

ENFORCEMENT’S SUPPLEMENTAL BRIEF

REGARDING MOTIONS TO SEAL

On June 15, 2022 and June 30, 2022, the Division of Enforcement (“Division”) filed motions to seal two notices (the “Notices”) respectively containing reference to the Securities and Exchange Commission (“SEC” or “Commission”)’s November 9, 2021 Non-Public Order Directing Examination and designating Officers Pursuant to Section 8(e) of the Securities Act of 1933 (“8(e) Order”). On June 16, 2022 and June 30, 2022, American CryptoFed DAO LLC (“Respondent” or “American CryptoFed”) respectfully submitted two oppositions (“Oppositions”) corresponding to the Division’s motion to seal the two Notices.

On September 16, 2022, the Commission ordered “the Division shall submit by September 23, 2022 either a brief, not to exceed three pages in length, addressing why filing the Covered Documents under seal is still warranted or a statement withdrawing its motions to seal” and “Respondent may file a response by September 30, 2022, not to exceed three pages in length, addressing the same matters to be addressed by the Division.”

On September 21, 2022, the Division filed its SUPPLEMENTAL BRIEF REGARDING MOTIONS TO SEAL (“Brief”), in which the Division stated, “the Division

has no objection to the Commission issuing an order unsealing the two sealed Notices, and has no additional information or arguments why the Notices should remain sealed.”

Accordingly, American CryptoFed respectfully requests that the Commission issues an order to unseal the two sealed Notices.
