The changes include promoting a current staff member to Associate Director, adding a new position of Project Manager of Bender Melon Farm, and a new hire fulfilling the Stewardship Coordinator position.

"These exciting changes are a dynamic way to start the new year," says Mark King, Executive Director of the Mohawk Hudson Land Conservancy. "We are now better positioned to accomplish our many goals, expanding MHLC's impact in the region to better serve our communities."

- Sarah Walsh is promoted to Associate Director of the Mohawk Hudson Land Conservancy. During her five years as Conservation Director, she oversaw land stewardship and property acquisitions. Sarah was instrumental in many notable MHLC accomplishments. She has been actively pursuing the Conservancy's vision of connecting the Catskills to the Adirondacks. Passionate about equitable access to nature, Sarah is the driving force behind the 2021 Nature Bus service that connected city of Albany residents with outdoor destinations in the region. She orchestrated partnerships with Capital District Transportation Authority (CDTA), New York State Department of Environmental Conservation (DEC), and community organizations. Within the organization, Sarah initiated the Conservancy's Indigenous Land Acknowledgement and assisted in developing the organization's 2022-2026 Strategic Plan. Sarah earned a bachelor's degree in Wildlife Science from the SUNY College of Environmental Science and Forestry (ESF) and a master's in Science Education from University at Albany. As the Associate Director, Sarah looks forward to taking MHLC to the next level as a leader in regional conservation.
- The Conservancy welcomes Erick McCandless to the team in January 2022 as the new Project Manager for the Bender Melon Farm Preserve. Erick will help tackle efforts to transform the 175-acre Bender Melon Farm Preserve into a community asset. Upcoming projects include extending trail systems, site cleanup, and environmental restoration. Erick was an early member of the Conservancy in the mid-1990s and later served on the Board of Directors (2004-2009). • Marshall Lefebvre will be joining the MHLC as the Stewardship Coordinator in February 2022. Originally from southwestern Pennsylvania, Marshall holds a B.S. in Conservation Ecology from California University of Pennsylvania and has worked most recently as a research technician with the NYS Hemlock Initiative at Cornell University. In his new job starting later this month, Marshall will monitor MHLC's conservation easements, oversee maintenance of the 22 public preserves, and manage MHLC's more than 150 dedicated volunteers. Marshall's passion for community building and cultivating human/land connections will be well-suited for establishing vital relationships with landowners and managing MHLC's large fleet of volunteers.
