Program Update - Health Officer's Covid-19 Report - Dr. Malcolm Butler

<u>Health Officer's COVID-19 Report</u> – Dr. Malcolm Butler shared a PowerPoint presentation which detailed that COVID is rapid and wide spread transition, 14% of all positive within the last two weeks; hospitals are filling with tenuous overflow capacity; Thanksgiving this year will be unusual and memorable. Dr. Butler shared a variety of data graphs related to total case numbers, testing numbers, new deaths reported and demographics. Discussion followed.

Public Comment – Chair Dan Sutton opened the floor to public comment on Resolution 2020-001. Dr. Karina Vega-Villa provide comment in favor of resolution 2020-001. Brian Herling provided comment in favor of resolution 2020-001. Following public comment, Chair Dan Sutton comments on the resolution; thanks the public for their comments, the message that needs to be sent to the community is one of solitary, working together, cooperating for the success of the community and help improve. Interim Administrator Nate Weed informs the public of the upcoming town hall meeting. Chair Dan Sutton asks the public if there are any new issues that would like to be discussed. No further comment.

New Business – Chair Dan Sutton provided an update on the CARES funding and Covid funding. Mayor Jerrilea Crawford inquired about the current process of hiring a Health Administrator. Vice Kevin Overbay states, there has been 31 applicants and also states Dr. Butler will be a part of the process. Interim Administrator Nate explained the interview process. Once the top two – four candidates are identified, the Board of Health will have an opportunity to meet, greet and have a formal interview with the candidates in an executive session meeting. Interim Health Administrator Nate states they are in the final stages of making an offer to a new board secretary, this person will also serve as the administrative assistant and as the public records request officer. They are currently in the process of recruiting for the Environmental Health Director. Governor Inslee announced additional Covid-19 restrictions with rules that will go into effect tonight at midnight. Looking in to reclosing and readjusting what we do in the community. Interim Health Administrator Nate requested for the board to move Veronica Farias the Public Information Officer in to an Associate Administrator role.

Vice Kevin Overbay made a motion to approve the Associate Administrator position and the appropriate salary range.
