NOTABLE AND REPORTED CASES

Mercedes Travis Brewer v (1) Stanley Mann (2) Fortis Lease UK LTD (3) Stanley Mann Racing Ltd (2012); [2012] EWCA Civ 246; LTL 7/3/2012: [2012] RTR 28 (Asset finance claim regarding Hire Purchase implied terms of quality and description – appeared in High Court and, un-led, at 5 day successful appeal at Court of Appeal)

Carol Keefe (Widow & Personal Representative of the Estate of Thomas Keefe, Deceased) v Isle Of Man Steam Packet Co Ltd (2010); [2010] EWCA Civ 683; LTL 17/6/2010. (Noise induced hearing loss whilst working on ship. Evidential burden on shipowner where no noise measurements taken. Mr. Brant appeared successfully at 1st instance, and also un-led in the Court of Appeal.)

Jayne Spencer v Wirral Metropolitan Borough Council (2008); LTL 1/10/2008 (Highway liability claim, tree root in Port Sunlight conservation area causing personal injury – whether breach of duty. Mr Brant appeared successfully at first instance and on appeal).

London North Securities Ltd V (1) Tony James Meadows (2) Michelle Debra Meadows (2005) [2005] EWCA Civ 956; LTL 27/7/2005 (Consumer Credit claim, agreement held unenforceable, appeal successfully resisted. The case attracted widespread media attention. Mr Brant won the case un-led at first instance, and also appeared and argued at the successful Court of Appeal hearing).

MBNA Europe Bank Ltd v Lynne Thorius (2009) LTL 4/1/2010: [2010] ECC 8 (Consumer Credit 'Unfair Relationship' arising due to payment protection insurance advice combined with a significant undisclosed commission to the Lender on sale).

AXA Sun Life Services Plc v Michael Cannon & David Piper [2007] EWHC 2466 (QB); LTL 13/12/07 (Misrepresentation alleged by Defendants resisting a claim for agency advances by Claimant. Mr Brant appeared successfully for the Claimant).

Abbey National Business Equipment Leasing Limited v Dora IFE, Current Law 03/723 (Asset finance – Summary Judgment successfully obtained for Claimant).
