
- 4. Field observations, problems, and decisions

- b. The clips are breaking off on the control panels, this is something Fleming is working with the manufacturer on
- 5. Identification of problems impeding planned progress
 - a. Control panel clips
- 6. Review of submittal schedule and status of submittals
 - a. Grade Calculations
 - i. Coesse is about 65% complete
 - b. As-built from MLS
 - They need to add coordinates and labels to their drawings for infrastructure and deflection points
- 7. Review of off-Site fabrication and delivery schedules
 - a. Storage at Aqua Indiana of the grinder stations 5 right of entries are unsigned
 - b. Grinder station extensions
 - Need to see if these can be stored inside and get a count on how many are to be used after lateral verifications are complete




- 8. Progress Schedule

 - b. Mobilize to Coesse
 - i. Grinder station lateral verifications and mainline
 - ii. Service Laterals and Grinders
 - iii. Control panels
 - iv. Start up
 - v. Restoration
- 9. Corrective measures to regain projected schedules
 - a. Fleming will be continuing to work Saturdays
 - b. Three crews are on this project
- 10. Planned progress during succeeding work period
 - a. Pressure testing in Stable Acres and continuity testing
 - b. Startup in Stable Acres
 - c. Grinder station lateral verifications in Coesse
 - d. Finish Mainline in Coesse and laterals/grinder station installations
