- New Business – Kellia Phillips. Martuice Brooks – The health and safety committee has revised the COVID-19 policies. The policies will be shared later (August 23?).
- DFSS Executive Updates – Kellia Phillips. Martuice Brooks introduced Dr. Funk from the IDPH to share the presentation.
 - CDPH Presentation – Dr. Funk has the floor. She and her team will discuss the partnership going forward, respiratory illnesses, etc. By collaborating, we help schoolchildren and families stay healthy. We can help prevent the spread of communicable diseases. Ms. Gaddam has the floor. She and her team do contact tracing of the outbreak cases of COVID-19, Monkey Pox, Ebola, and other communicable diseases. 1. Topic – early childcare education partnerships – sharing resources. July 01, 2023, there are changes in the guidelines. Only outbreaks need to be reported. Mission/Vision – working with communities and partners to create a healthy, safe, resilient Chicago. Through these works, Chicago thrives and achieves their wellness. 2. Objective – to promote the environment that supports the education and health of all Chicago young children. (1) keep young children in schools/daycares, (2) keep young children healthy and free of communicable diseases, (3) minimize the burden on staff, family, and administrators. Reportable diseases: some must be reported immediately, and some must be reported within 24 hours. School and childcare centers are mandatory reporters. Here is the IDPH disease response flowchart. CDPH informs ECE of cases of notifiable disease – CDPH gathers more information from ECE – CDPH creates an epi curve (graph) – CDPH decides about additional testing and reports to IDPH. Example 1–

if several students are out sick and their parents report Vomiting/Diarrhea. What actions must be taken? Click on the IDPH guidance for ECEs and follow those steps. Norovirus is most prevalent in school children. In daycares, shigellosis is more prevalent and contagious. School children can return to school if they are fever-free (24hrs w/o medication). Example 2. Respiratory illness – young children with a runny nose or sore throat. What actions are to be taken? Send an email to schoolscd@cityofchicago.org for guidance and support. A take-home message – routine cleaning and disinfecting work effectively to stop the spread of influenza, RSV, and SARS-Cov-2. Other measures to stop the spread of germs are washing hands frequently, immunization current, covering coughs and sneezes, staying home when sick, and disinfecting the living environment.
