Content Areas Reports – Sharay Johnson updates the content area reports. (ERSEA) -The federal program begins September 05th 2023. The PFA and PI begin the program on August 21, 2023. We continue to enroll children in all the programs throughout the year. Our early learning enrollment hotline (312-229-1690) is available for all parents to enroll their children. About 75% of children are enrolled in federal programs in September. During the Summer months, enrollment of children was impacted. Many of them are out of school and on vacation. DFSS-CSD continues to receive migrants. (Health/Nutrition) - DFSS completes the review of COVID-19 policy. Also, DFSS has met with managers who are responsible for lead in the drinking water. Claridigm, Inc. provides a presentation during the September 21, 2023, meeting at Truman College. (Mental Health) – DFSS participated in a National OHS webinar. This session provides mental resources for EHS agencies servicing infants/toddlers. (Disabilities) – Christopher House, Belden site is implementing the inclusion pilot model. Erickson discusses needed training and technical assistance for the delegates. DFSS met with disability coordinator to provide an overview of the upcoming FA2 review. DFSS-CPS presented two workshops at the King Center. (Education) – Summer child outcomes for all children transition to kindergarten compiled. DFSS-CSD determines that the social emotional of the domains is essential for a child's readiness for success in kindergarten. We have 20% emerging and 80% accomplished. Last year, our goal was 85%. (PFCF) – RCADD of the South side locations (King Center and 10 South Kedzie) has moved all the services to the UIC campus. The UIC is to ensure to maintain the quality of services virtually. Continue updating data collection systems to help track the attaining of Illinois Gateway credentials for Chicago Early Learning Providers. (Fiscal) – The FY24 federal gran

applications were due on 09/01/2023. DFSS starts giving the agencies' fiscal report monthly – notifying them of their rate of invoicing/spending on a monthly basis. This is to ensure all agencies remain on track with their invoicing and expenditures for timely billing and spend down.
