

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.thecorehouston.com](http://www.thecorehouston.com), and The Core Health and Fitness and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to The Core Health and Fitness include [www.thecorehouston.com](http://www.thecorehouston.com), The Core Houston, NPTI Houston, Planet Beach Spray and Spa and Spaces at The Core. The The Core Houston website is a Fitness Membership and Facility Information site. By using the The Core Houston website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, The Core Houston may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number

The Core Houston may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

We do not collect any personal information about you unless you voluntarily provide it to us. ## Sharing Information with Third Parties

The Core Houston does not sell, rent or lease its customer lists to third parties.

- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.
