

Privacy Statement Orange Wings BV

This is the privacy statement of the company with limited liability Orange Wings BV, hereinafter referred to as: Orange Wings. Orange Wings is registered with the Chamber of Commerce under number 27198342 and is located at Houtlaan 519, 3016 DA Rotterdam, NL. This document explains how Orange Wings handles the processing of your personal data. Orange Wings takes the greatest possible care when processing your personal data.

Obtaining personal data

If you use the services of Orange Wings, you provide a number of personal data to Orange Wings yourself, or personal data is obtained from you in the context of the agreement. Personal data is understood to mean all data relating to an identified or identifiable natural person.

Categories of personal data

Orange Wings collects and processes the following data:

- Name, address, location, telephone number, email address;
- Company details, including VAT number and Chamber of Commerce number;
- Financial details;
- Other personal data provided by you voluntarily, including any information contained in your pitch deck.

Way of Collecting and Processing

Orange Wings collects and processes data when you:

- Use or view our website via your browser's cookies.
- Register online or contact us via one of the contact forms.
- Register online for our newsletter.
- Provide voluntary information through our website, including but not limited to a pitch deck.
- Provide information in course of our collaboration on the basis of an agreement.

- Contact us about a vacancy.

Purpose of processing

The purpose of processing personal data by Orange Wings is to:

- contact you to inform you about the services you have purchased and/or the pitch deck you have submitted and its implementation;
- be able to perform its services;
- improve its services;
- be able to make payments;
- comply with legal obligations;
- be able to make marketing and communication expressions, including improving the website by analyzing visitor behavior on the website;
- be able to send newsletters;
- exchange data with third parties for the performance of its services to you, insofar as this is necessary.

Basis of processing

The processing of personal data is only possible on the basis of the following principles: (i) legal obligation, (ii) execution of the agreement, (iii) obtained (explicit) consent from the data subjects, and (iv) legitimate interest. When providing the services of Orange Wings, personal data is processed. Orange Wings only processes data that is necessary for (improving) the service and handles the (personal) data it has collected about you and your use of the services with care. The basis for processing this data is the agreement that you have entered into with Orange Wings. Your personal data can also be processed by visiting the website www.orangewings.nl if you have given permission for this.

Necessity of processing

The processing of your personal data is necessary to be able to carry out the service. The services offered by Orange Wings cannot be fully performed without the processing of your personal data. If your explicit permission is required for specific purposes with regard to the personal data, you are required give permission for this separately.

Automated decision-making

There is no automated decision-making.

Retention period

The personal data processed by Orange Wings are stored in accordance with the relevant laws and regulations on a secure (cloud) server located in [location]. If a longer retention period is necessary on the basis of legislation or regulations, the personal data will be kept longer in accordance with these requirements. All (obtained) personal data will not be kept longer than strictly necessary. Once the retention period has expired, Orange Wings will delete your data and any record of it.

Processing by third parties

Orange Wings only shares personal data with third parties if this is strictly necessary for the execution of an agreement and to comply with relevant laws and regulations. No personal data is sold. Orange Wings may have a legal obligation to share personal data with third parties. If personal data is shared with third parties, processing agreements are concluded for this. The third parties with whom to share personal information are:

- Website administrator, for the purpose of executing the agreement. The categories of personal data that are processed are the contact and name and address details.
- Third parties engaged for the performance of the agreement. The categories of personal data that are processed are the contact and name and address details.

Orange Wings takes the protection of your personal data seriously and takes into account the state of the art, implementation costs, as well as the nature, scope, context and the processing purposes and the risks that differ in probability and seriousness for the rights and freedoms of persons, appropriate technical and organizational measures to ensure a level of security appropriate to the risk.

Cookie statement

Orange Wings uses technical and functional cookies. Cookies are small text files that are sent along when you visit a website to make the user experience of visitors more efficient. Orange Wings may, by law, store cookies on your device if these cookies are strictly necessary to use the website. Other types of cookies require your permission. Orange Wings advises you to accept the cookies in connection with the user-friendliness of the website. Visitors to the website have a check-in option.

The cookies that Orange Wings uses are functional cookies: these cookies ensure that the website works properly. These cookies have no consequences for privacy, so that no permission has to be requested and granted. For example, these cookies store your browser settings so that our website can be viewed best, or that the website remains accessible (load balancing), but also cookies that ensure that no other cookies may be placed (no-follow).

With your permission Orange Wings places "tracking cookies" on your computer. Orange Wings uses these cookies to keep track of which pages you visit, in order to build a profile of your online behaviour. This profile is not linked to your name, address, e-mail

address and the like, and therefore not considered personal data. They are only used to tailor advertisements to your profile so that they are as relevant to you as possible.

Cookies from Google are also placed on the Orange Wings website for the purpose of Google Analytics. This means that Orange Wings cannot link information to a natural person. Orange Wings does not keep any information about what you do on the internet. Google Analytics may be required by applicable laws and regulations to provide access to this data. Use of social media

Orange Wings uses cookies from third parties to optimize the website. Some cookies are placed by third party services that appear on the website. Third parties mean Google Analytics and social media (LinkedIn, Instagram). The privacy and cookie policy of the relevant company applies to the use of cookies from other companies (third parties). When you click the social media button on the website, a social media cookie is placed. This allows the social media party to recognize your IP address as soon as you share an article from the website. For the cookies of social media parties and the data and/or personal data they collect with them, Orange Wings refers you to the privacy and cookie statements of these parties.

Your consent to the sending of marketing emails can be withdrawn by you at any time by clicking “Unsubscribe” at the end of the marketing email. Withdrawing consent does not affect the lawfulness of processing carried out prior to the withdrawal of consent.

Browser Settings

If you do not want websites to place cookies on your device that you use to view the website, you can adjust your browser settings. Before a cookie is placed, you will receive a warning and you must give permission for the cookie. Failure to do so may, for example, result in the website not working properly. You can adjust the settings of your browser so that your browser refuses all cookies and also cookies from third parties. You can also delete placed cookies. For this you have to adjust the settings of your browser via preferences and then you can adjust the privacy settings.

Right of data subjects

As a data subject you have the rights listed below. In order to execute any of your rights, please contact Orange Wings at privacy@orangewings.nl.

- **Right of access;**
As a data subject, you have the right to obtain a definitive answer as to whether or not your personal data is being processed and, if that is the case, to inspect the processing thereof.
- **Right to rectification;**
You have the right to obtain rectification and completion of incorrect data.
- **Right to erasure;**
A data subject must obtain erasure of personal data concerning him/her without undue delay.
- **Right to restriction of processing;**
As a data subject, you have the right to restrict the processing of your personal data.
- **Right to data portability;**
A data subject has the right to obtain the personal data concerning him that he has provided to Orange Wings in a structured, common and machine-readable form in order to possibly transfer this personal data to a third party. A data subject can also instruct Orange Wings to transfer this data directly to a third party.

- **Right to object;**

The data subject has the right to object at any time, on grounds relating to his particular situation, to the processing of personal data concerning him/her, including profiling based on those provisions. Orange Wings will discontinue the processing of personal data unless there are compelling legitimate grounds for the processing that outweigh the interests, freedoms and rights of the data subject related to the exercise, establishment or defense of legal claims.

Complaint
