

The CTC: A Transformative Credit

In 2021, hundreds of thousands of families in Puerto Rico became eligible for the Child Tax Credit (CTC) as a result of the American Rescue Plan Act (ARPA). The Instituto del Desarrollo de la Juventud (IDJ) surveyed heads of households with dependent children to learn about the impact of this credit on their lives.

The survey revealed that:



Families used CTC funds in a balance way



38% used it for miscellaneous purposes



35%

paid debts



26%

saved it



54%

prefer an annual payment rather than advanced monthly payments



29%

of low-income individuals found it difficult or somewhat difficult to apply for the CTC

Individuals without college degrees were more likely to receive identity verification letters.



63%

of individuals without college degrees received identity verification letters

of individuals with college degrees received identity verification letters





Recommendations:

- Expand the availability of free income tax return preparation and identity verification services, especially in rural areas and the island municipalities (Vieques and Culebra), where many vulnerable families live. Collaboration between the federal, local, and municipal governments in coordination with community-based organizations is essential to expand the support network for

• Increase the number of Spanish-speaking IRS customer service technicians.

There's no way for us here . . . considering that we speak Spanish . . . there's no way that [we] can do this alone without [the help of] an English speaker. [. . .]—

- Provide Puerto Rico with the same CTC access tools that are available in the United States. Moderate the exorbitant costs of income tax return preparation services for
- low-income families.

They charged me \$200 for each child, and I have two. When the funds arrived, they collected it. - mother from Bayamón

- **Provide the CTC to people without earned income.** The survey revealed that 44% of the beneficiaries did not earn income from employment in 2021. The CTC benefit helped reduce the extreme poverty and instability faced by these families.

• Develop an anti-fraud campaign to inform individuals about the income tax

return preparation service, their rights, and best practices.

Allow families to choose to receive funds as monthly payments or as a lump sum. Although residents of the United States could choose the form of disbursement, this option was not available.
