
Wilshire Liquid Alternative Multi-Strategy Index^{sм}

The Wilshire Liquid Alternative Multi-Strategy Index[™] measures the performance of the multistrategy strategy component of the Wilshire Liquid Alternative Index. Multi-strategy strategies invest in multiple alternative managers/fund of funds and replication strategies. Created in 2014, with a time series of data beginning on December 31, 2002, the Wilshire Liquid Alternative Multi-Strategy Index (WLIQAMS) is designed to provide a broad measure of the liquid alternative multistrategy market. The Wilshire Liquid Alternative Multi-Strategy Index, when combined with the performance of the Wilshire Liquid Alternative Global Macro Index (WLIQAGM), Wilshire Liquid Alternative Relative Value Index (WLIQARV), Wilshire Liquid Alternative Equity Hedge Index (WLIQAEH), and Wilshire Liquid Alternative Event Driven Index (WLIQAED) comprise the Wilshire Liquid Alternative Index (WLIQA).




