COMMITTEE REPORTS-

Audit Committee-nothing to report

Executive Director-Todd is currently working on cell 1 and cell 5 with waste replacement and containment berms. B & L are assisting us with submitting a cost associated with the berms to EFC for

reimbursement. John Usher from the NYS department of Labor was on site August 28th, to complete a training on confined space. There were five employees that took part in this training. We hired a new employee who will be repairing the containers and equipment. B & L completed the Tier 2 landfill gas sampling as required by the NYSDEC. Construction meeting with Kubricky on September 13, 2019 and they are approximately 50% complete with the mass excavation work. Kubricky anticipated being complete by the end of October. Cell 4 secondary pump failed this month and was replaced with a backup pump. The pump has been sent out for repair to Pump Service and Supply. The sewer transfer pump by the old shop failed for the third time three years in a row, currently its being replaced with a pump more suitable for the application. The pump was purchased through Pump Service & Supply and installed by the Regional Landfill employees. The wiring connection was completed by Dow Electric. The Landfill and transfer stations are getting caught up on the tire removal. There are currently a few loads of tires left. Todd also brought to the board's attention the current price of tire disposal. Next, will be the refrigerators and air conditioners we have to recover the freon out of the units before we can send them for scrap metal. Also needs to be addressed is possibly increasing the annual fee for the recycling permits to cover trucking cost. Todd had a meeting with the company that we use for disposing of ewaste. In that meeting they informed him they are raising the rates and it would consist of \$.15/pound on top of the current price.

Governance Committee-Nothing to report at this time.

Recycling Committee- Brandon Titus said the meeting has been rescheduled for October 9, 2019 and he stated that District 7 Legislature Lindy Ellis and the Franklin County IDA will be in attending as well. **Scada System**- Nothing to report at this time.

Treasurer- The accountants sent a balance sheet and an income statement as of June 30, 2019. The Board was given the 2019-2020 proposed budget.

At approximately 4:02 pm, Dean Lefebvre made a motion to enter into executive session to discuss litigation. Edward Robideau seconded the motion which was carried by voice vote.
