Audit Committee- Dean, Boyce - Nothing to report at this time.

Executive Director- Todd - BST (Accountants) will be arriving on June 23rd & June 24th to go over a few items. They also will be discussing the ABO reporting, amending the budget and preparing for the annual audit. The software company for our scale system (Paradigm) was on site to update and trained all employees. The upgrade also included a new printing software and signature tablets. There is no longer 3- part receipts. The Regional Landfill will be hosting a Hazardous Waste Day on August 21, 2021. The company preforming the collection is US Ecology formally known as Op-Tech. In January we will be applying for a NYDEC reimbursement grant that will cover 50% of the total costs. Perras Companies are on site screening material for the capping of cell 3 and 4. It has been brought to our attention that the Lake Clear Transfer Station scales need to be replaced. When the scales were converted from electric to hydraulic the deck was not replaced, and it is not intended for heavy truck use, and it has caused the deck to flex. Todd would like to replace the deck sooner than later. He is hoping to replace the scales by fall. Statewide Aquastore will be here to reseal the exterior leachate silo this summer. During the annual inspection last year this was recommended to be completed this year.

Governance Committee-Brandon, Kip & Curt - Nothing to report at this time. Recycling Committee- Brandon- We currently have our intern researching electric charging stations and information on recycling.

Treasurer- Boyce: Nothing to report at this time.
