We are anticipating the steel building to be delivered at the end of January. Todd has purchased two air quality detectors that will be installed on two of the property lines. This information will be sent to the computers in the office to better maintain the odor. Todd wants to have the data supporting the Authority should we have odor complaints. The board was given information on a new 740 GC articulated truck. We currently have a 1995 CAT 350 that has been in use since 1995 and is getting beyond its useful life. The articulate truck is used for hauling cover material, making roads, and moving waste when needed. There is currently enough funds in the equipment replacement fund to cover

the purchase of this piece of equipment. B&L is currently on site performing $4^{\rm th}$ quarter well testing and leachate testing.
