EVENT RULES

1. The applicant must be present for check-in and sign the release of responsibility.
2. Check-in and set-up will be Friday, April 23, 2022 starting at 9:00 a.m. Security will be provided with the understanding that the Talona Ridge RV Resort and Georgia Mountain Trails Partnership is not, and will not be responsible in any way for loss or damage to participant's property. Exhibitors are responsible for their personal and property liability.
3. Exhibitors must furnish their own display tables, skirting, chairs, extension cords, tents, etc. All displays must be designed, constructed and operated in good taste.
4. All displays, transactions, signage, and activities must be confined to the exhibitor's assigned space. Signs, tents, canopies or any other part or display may not extend over or into walkways or RV pads.
5. All food vendors or food trucks must show proof of insurance.
6. Gas powered generators are strictly prohibited.
7. Georgia State/County Sales tax of 7% MUST BE charged on all sales. Exhibitors are solely responsible for collecting, reporting and paying all taxes collected to the Georgia Department of Revenue, Compliance Division. Forms are available on the state website.
8. Electricity is a paid amenity and is limited to those who specifically need it to demonstrate their craft, food production or other necessary functions.
9. Disruptive, rude or disrespectful behavior toward other vendors, volunteers, patrons or merchants will not be tolerated. Management reserves the right to remove or ban any person(s) who are not in compliance with the festival rules and regulations.
10. A signed application constitutes a contract to follow all rules and regulations. It is a contract to participate, personally, if accepted. Any exhibitor not abiding by these rules set by Georgia Mountain Trails Partnership and the Talona Ridge RV Resort will forfeit their privilege to participate in the current and future shows.
