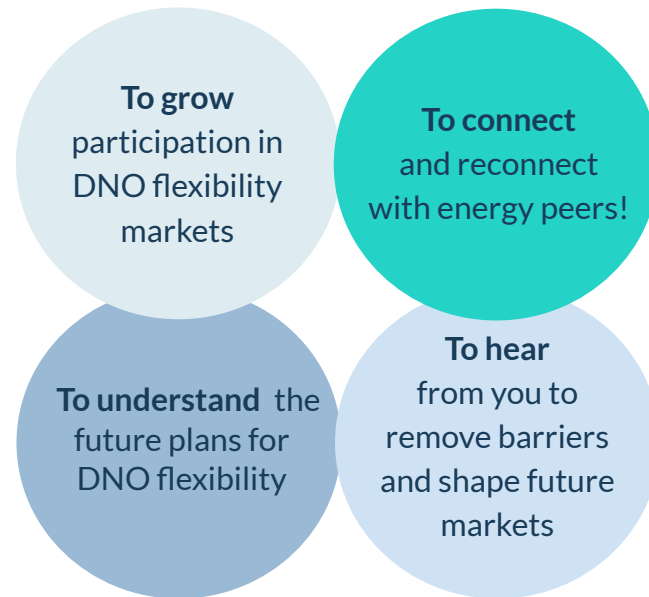
Event coordinated by Piclo, and four UK Distribution Network Operators (UK Power Networks, Electricity North West, SP Energy Networks, Northern Powergrid)

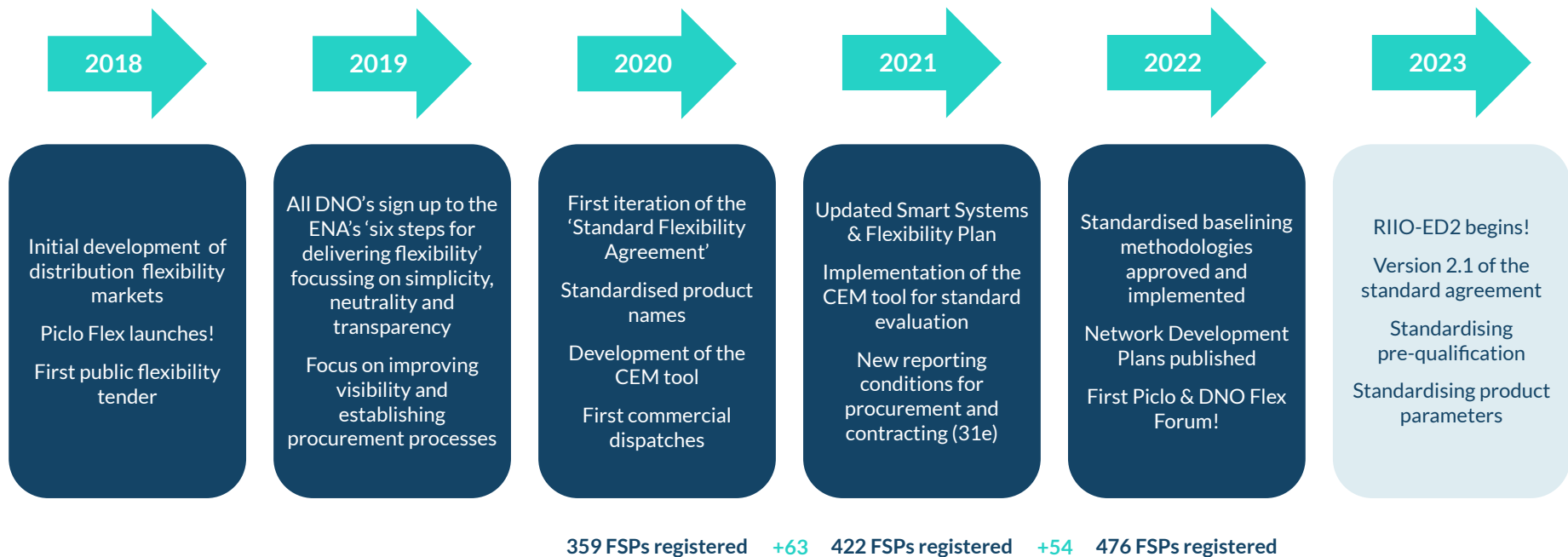

Flex Forum: Growing DNO flexibility markets to reach net zero

Progress since 2022

Data availability:

"The value proposition of DNO flex services must be made clearer, DNOs must increase visibility of what kind of services will be needed in future"

Visibility on future services is available through the NDP Reports published by each DNO

APIs

"APIs can help with automation for FSPs", "There is a lack of standardisation across operations and dispatch is a barrier - e.g. Dispatch APIs"

Piclo have published a number of APIs for FSPs and DNOs to make use of and will work alongside industry to move towards common APIs by summer 2024

Short term markets

"Short term markets are a significant opportunity for DNOs to prioritise over ED2", "A variety of short, medium and long term contracts should be available to suit different FSPs"

Piclo has developed end-to-end functionality to deliver short-term markets and are working alongside the DNOs on how to enable this

Procurement Standardisation

"The procurement process is flawed and needs to change", "The lack of a framework contract acts as a barrier to participation"

Piclo will work alongside DNOs to deliver a standardised PQQ and Framework contract from Autumn 2023

Collaboration sessions

Workshop 1: Data & information

Discussion prompts included:

- How do Flex Providers find out about the tenders?
- What information do Flex Providers need to assess whether to participate in any tenders?
- What do Flex Providers think about the information/support provided by Piclo and the DNOs, in terms of helping decide whether to participate in a tender?
- Previous competition data available on the Piclo data hub. Do Flex Providers access this? Is this useful in informing future decisions?

Items raised in discussions included:

- Flex Providers use a range of sources to find out about competitions (Linkedin, twitter, emails) - no clear main source used
- Some frustration at needing to look at different information across the different DNOs, and at different documents, as well as Piclo
- Some FSPs mentioned difficulties in uploading large file sizes
- Some FSPs mentioned they would like more information on how much flexibility was actually dispatched post competition - some were unaware on information already available

Collaboration sessions

Workshop 2: Qualification & contracts

Discussion prompts included:

- What are the challenges you are currently facing with the asset and company qualification processes?
- What other experience do you have of signing Framework Agreements? What has that experience been like (pros and cons)?
- What are the challenges you foresee with the standardisation of providing asset data / company data?

Items raised in discussions included:

- It was generally felt that company qualification was relatively straightforward, although some FSPs would prefer that once qualified for one DNO, that could be replicated to others instead of re-entering the same process
- Some FSPs asked to standardise DPS and company qualification and its duration further
- There was a range of understanding and experiences of Framework Agreements
- Some, typically larger, FSPs indicated that Framework Agreements would require more senior-level sign-off
- Most FSPs welcomed the move to standardisation in contracts, including removing concerns from new entrants that other FSPs were negotiating terms
- Some FSPs asked whether it would be useful to keep their asset information up to date, even when tenders were not live - it was felt it would be useful, but there was discussion on how to encourage FSPs to do that given differing levels of resourcing within FSPs

Collaboration sessions

Workshop 3: Decision making: Bid & dispatch

Discussion prompts included:

- Do you understand why your bids are accepted / rejected?
- How do you use this information to inform your future bidding strategies?
- What other information would help you improve your bidding strategies?
- How do you dispatch your assets currently?
- How would you like this process to work in future?
- What are the opportunities and challenges with short term competitions?

Items raised in discussions included:

- On dispatch of assets, some FSPs talked about working with the DNOs and the process working well.
- Some FSPs, particularly aggregators, voiced interest in short-term markets given at domestic level, consumers need to be able to come and go , so certainty of fulfilling longer term contracts can be more challenging
- In general, FSPs would like more information on why assets end up being dispatched / activated, and which ones; and why bids are rejected
- Some FSPs asked for more info on how frequent dispatch will be - although estimated utilisation hours are provided within tenders.

Key comments & Next steps

Standardisation

- **Standardisation of PQQ**

FSPs asked for greater standardisation, as well as an indication on what clauses were mandatory

- **Next steps:** This is a priority across all DNOs through the ENA Open Networks programme, with the Standardised PQQ expected to be implemented from the Autumn 2023 tenders

- **Standardisation of DPS**

DPS durations vary across DNOs. Several FSPs suggest greater alignment could be helpful.

- **Next steps:** The DNOs using Piclo Flex will explore how to standardise the DPS process

Key comments & Next steps

Visibility

- **Better visibility of historical data**

Several FSPs were not aware of the historical data available through the Piclo Data Hub

- **Next steps:** Piclo will publish insights from the Data Hub to raise awareness of the site. Existing data sets include: GB DNO competition boundaries; GB competitions on Piclo Flex; historical data on confirmed bids
- All DNOs also published an annual Flexibility Services Procurement Report on their websites

- **Visibility of future tenders**

FSPs would like better visibility of future tenders. Several were not aware of the information already available through the DNO websites

- **Next steps:** In the Autumn, a refreshed Piclo website will build on the existing signposting to available information provided by the DNOs

- **Value of flex - forecasting and pricing at specific sites**

Forecasting for specific sites and location, and visibility of this including aspects such as utilisation, would help FSPs in choosing to bid, and also help attract investment; and FSPs asked for more support on pricing strategies

- **Next steps:** Piclo and DNOs are in discussion on how to improve forecasting and pricing visibility, including reviewing available calculators
- DNOs already publish ceiling prices

Key comments & Next steps

Support

- **More information, in one place**

FSPs would like a better overview of key information, in one place, which is currently available across different websites and documents

- **Next steps:** In the autumn, Piclo will conduct detailed research on what information would be most helpful to FSPs to inform any refreshed Piclo website with a GB overview of the competitions on its platform

- **Support for less experienced FSPs**

Less experienced FSPs asked for more support, particular at the earlier stages of the bidding process, with more practical guidance

- **Next steps:** FSPs can seek 1-2-1 meetings with DNOs; Piclo offer training and support; Piclo will release additional training support from Autumn 2023

- **Asset location - more support to confirm correct location**

A “pain point” was confirming asset location, with several FSPs asking for support to explore a better method for doing this

- **Next steps:** Piclo and DNOs are in discussion on how to improve
