

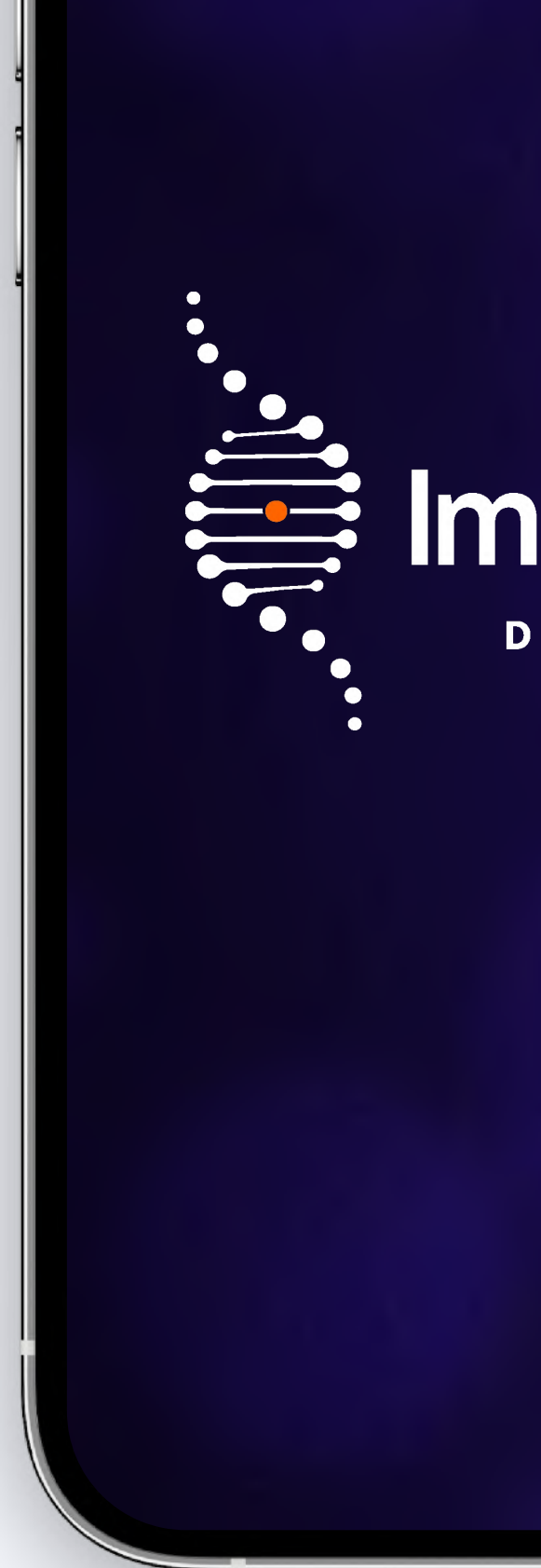
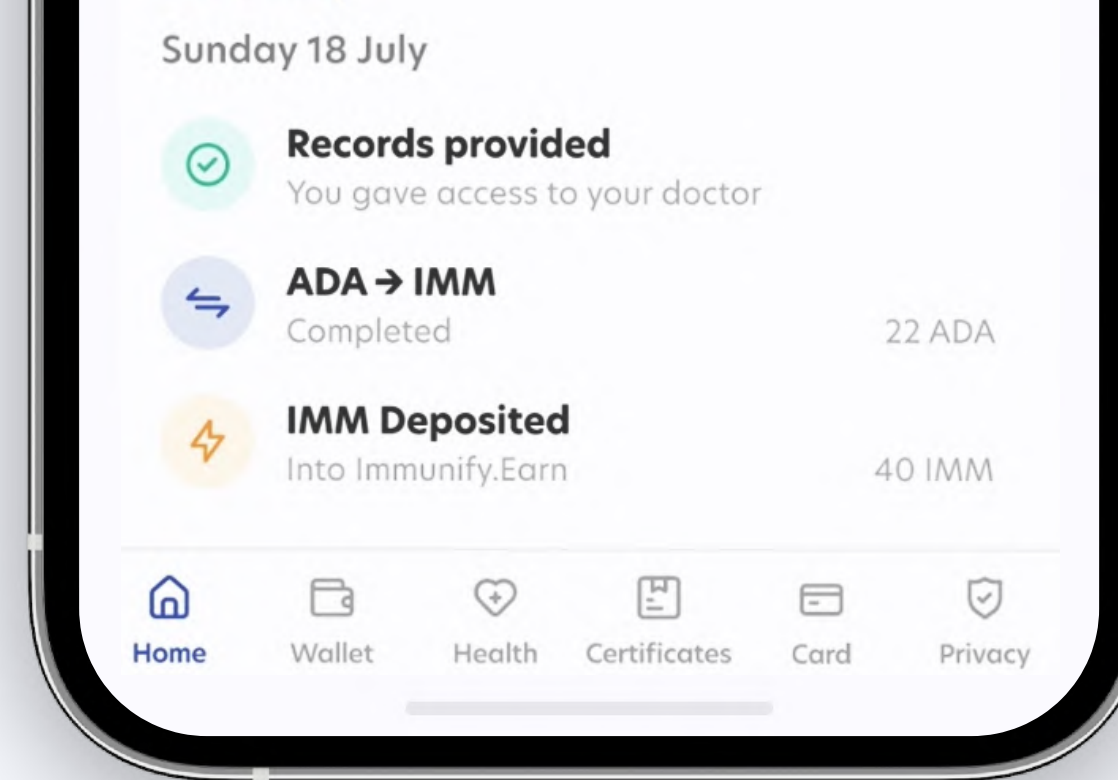

## Delivering DeSci —

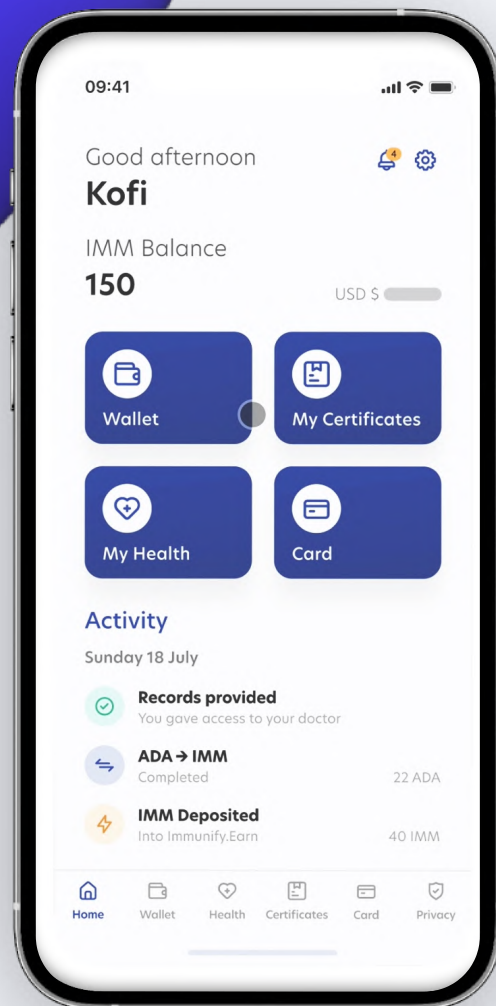

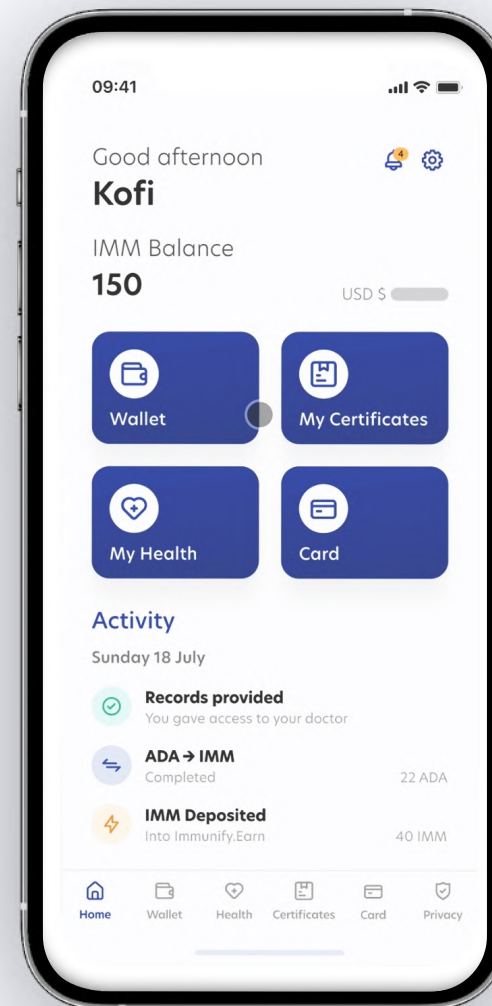

## IMM Token

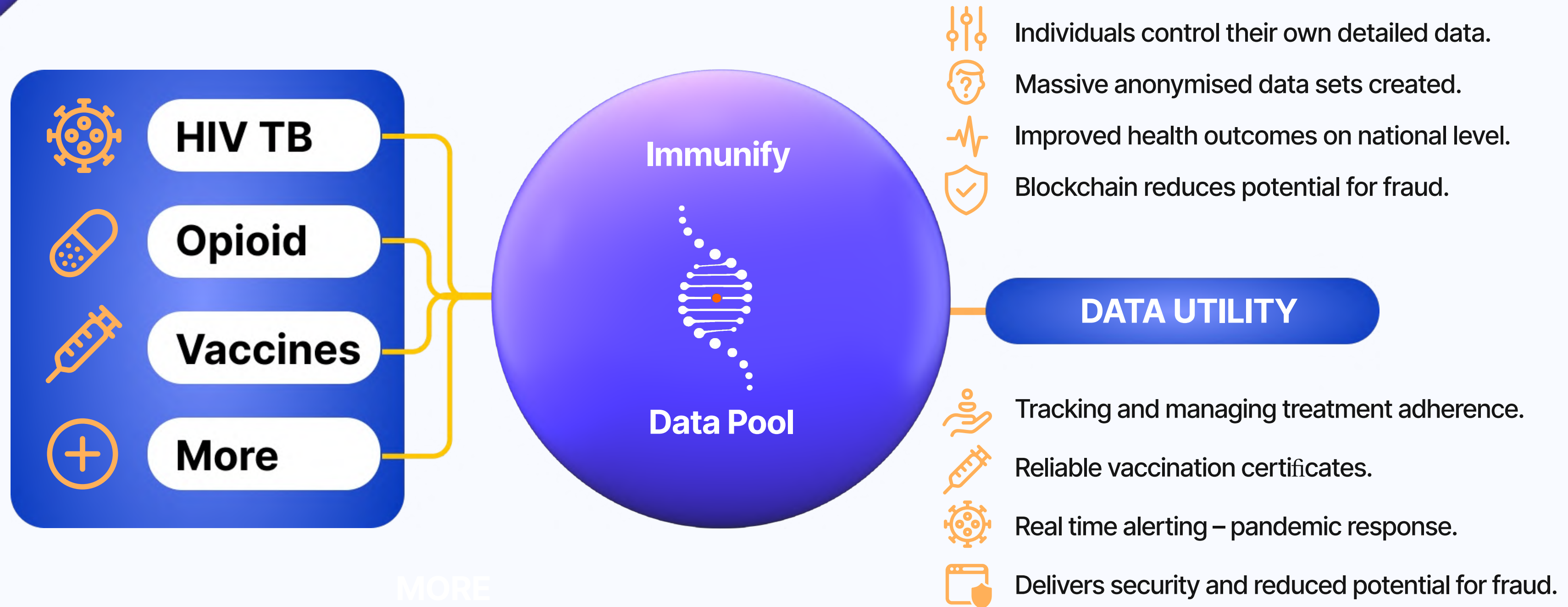


The Clinical App is the clinical interface to the platform; it allows Doctors, Clinics, and other medical institutions, to manage patients with a Electronic Medical Record (EMR) System.

Operational Beta in Kenya incentivizing patients, managing balances, granting access to medical certificates, and enabling consent for data sharing.

Listing in June. IMM token used as incentives for patients and health workers, purchasable by data samplers, with data-sharing rewards for holders. A portion of staking rewards goes to impact initiatives/pools.

# Data Revenue Model —

## Health management programs

01

- Infectious/chronic disease management: NGOs and governments purchase data to track the impact of their investments, generally charged at a percentage of program cost that is being funded.

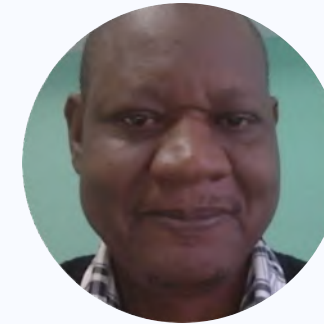

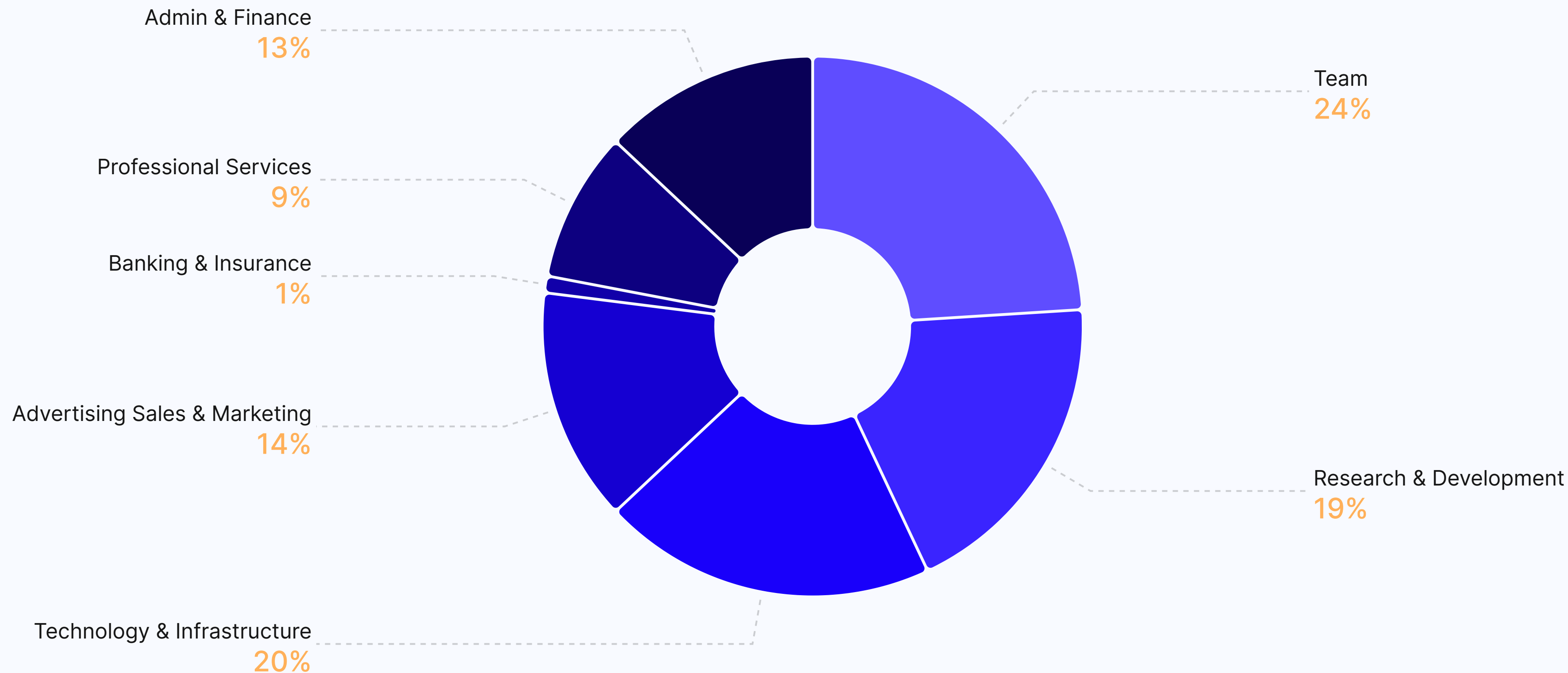

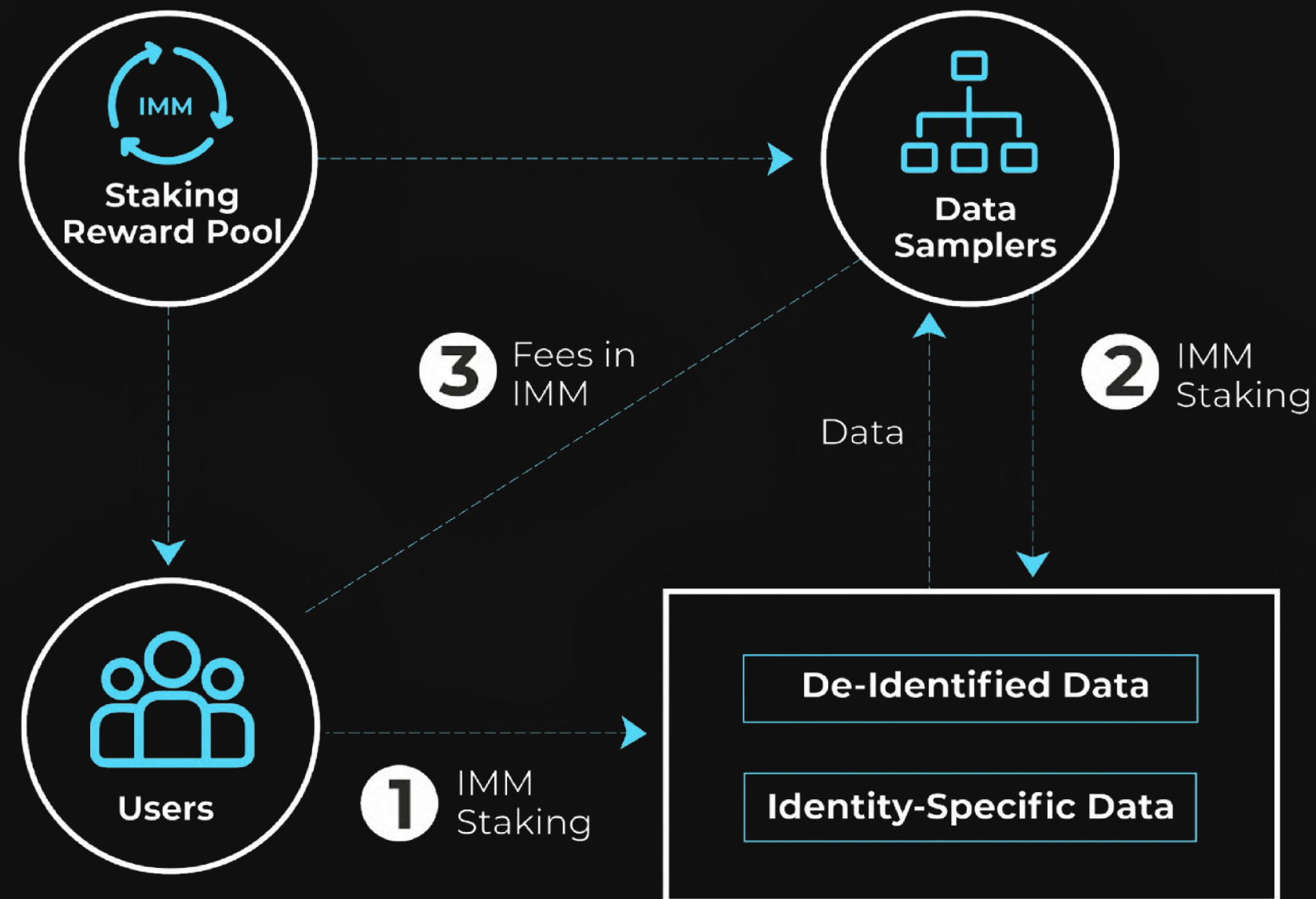

# Use of Funds

Seeking \$5 million in Series A funding and offering 6% of tokens in a strategic round worth 1.5 million.



# Token Utility —



The IMM Token has two staking functions and one transactional utility:

1. Users stake IMM to earn fees from Data Samplers who are paying for the anonymous license. The fee rate is inversely proportional to staking which gives Users, as a collective, an effective vote on the fees. ("User Staking") Users stake IMM to take tokens out of circulation. This has the effect of decreasing the (Gross) fee rate
2. Data Samplers who engage with specific users stake an amount of IMM per user for the duration of the engagement ("Engagement Staking")
3. Fees for the data license are paid in IMM tokens and distributed to both sets of staking in proportion to IMM staked.
4. All fees collected for the data are paid to User Staking and therefore this allows the system to respond dynamically to pricing and allows an economic push-pull to be in place between Users and Data Samplers to establish price taking and making.
5. In addition to the fees a Staking Pool has been set aside to bootstrap the model. This is set on a curve that follows a fixed time (front loaded) distribution and are added to the User Staking Rewards.



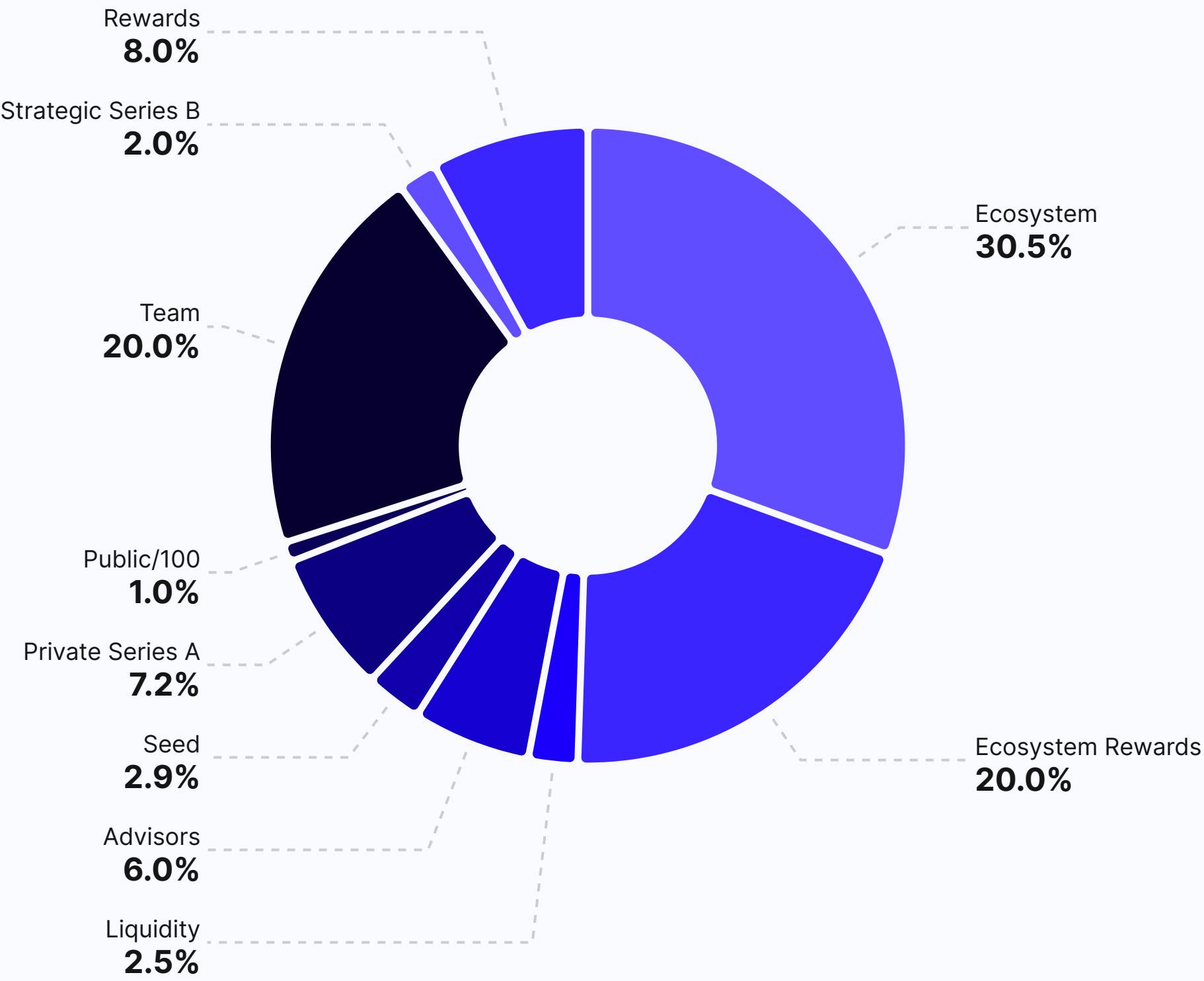
# Tokenomics —

The IMM token is a fee settlement token for the Immunify.Life platform. The token facilitates additional functions as both a deterrent to bad actors (via staking function) and a payment option (medium of exchange). The platform itself focuses on the sale of large scale anonymised medical data sets. Collected directly from an immutable source (blockchain), to governments, NGOs, and other commercial organizations.
