The Diabetes Patient Advocacy Coalition Recognizes Washington State Senator Karen Keiser with the DPAC Legislative Champion Award

OLYMPIA, WA – Presented to individuals who demonstrate a commitment to improving the lives of people impacted by diabetes, the Diabetes Patient Advocacy Coalition (DPAC) is honored to present Washington State Senator Karen Keiser with the DPAC Legislative Champion Award on January 18, 2024.

Sen. Keiser (D-Des Moines) has greatly impacted the diabetes community through her work championing, sponsoring and supporting patient-centered policies. A major diabetes win for Sen. Keiser in 2023 was championing Senate Bill 5729, which removed the expiration on the cost-sharing cap on insulin and made a \$35 cap on insulin permanent for Washingtonians. The Senator is a current co-sponsor of Senate Bill 5445, which would require 100% of drug discounts and rebates to be passed through to patients at the pharmacy counter, a major policy priority for DPAC.

"I am honored to receive the DPAC Legislative Champion Award, recognizing the Legislature's bipartisan efforts to make healthcare more affordable," said Sen. Keiser, who represents Washington's 33rd Legislative District. "We have to make sure everyone can afford to get the care they need. Capping out-of-pocket costs for insulin will make a tremendous difference to many diabetes patients across our state. But we still have much more work to do to drive better health outcomes for all Washingtonians, such as emphasizing cost-sharing fairness for patients at the pharmacy counter."

"Senator Karen Keiser has demonstrated dedication to the cause of affordable healthcare, particularly in addressing the critical issue of capping insulin costs for those with diabetes. Her efforts reflect a commitment to the health of every resident in Washington. It is with great pride that we present the DPAC Legislative Champion Award to Senator Keiser," said George Huntley, CEO of the Diabetes Patient Advocacy Coalition. "We look forward to further collaboration to improve the lives of all people living with, affected by, or at risk for diabetes."

The DPAC Legislative Champion award acknowledges those working collaboratively to understand the diabetes community, fighting to increase access and affordability to prevention and management tools and advancing patient-centered policies at the state or federal level for the 37.3 million Americans living with diabetes.
